- iv) Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.

### 3. **PRE-QUALIFICATION CRITERIA (PQC):**

- Vendor shall be ISO-9001:2008 certified company for quality management system. Valid certificate to be submitted along with offer.
- Vendor shall have experienced manufacturing & supplying of loading arm handling ATF/ MS/NAPHTHA/ HSD/SKO services to crude oil refineries within last 10 years from date of floatation of tender. PO copies and Inspection release note shall be submitted to substantiate the same.

### 4. <u>DOCUMENTS TO BE UPLOADED AS A PART OF PART – I: TECHNO-COMMERCIAL / UNPRICED E-BID:</u>

- a) Documents in support of PQC.
- b) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. The commercial terms & conditions should not be repeated in the offer
- c) Undertaking on account of Anti-profiteering provision under the Goods & Services Tax ("GST") Law(s) as per format enclosed.
- d) Bidder's Self-Declaration of black listing/holiday listing as per Performa enclosed.
- e) Technical Terms & conditions duly signed & stamped.
- f) Vendor Details as per Format enclosed.
- g) In case bidder is Micro & Small Enterprise (MSE), EM-II Certificate & Indemnity Bond as per clause no. 6 of NIT below for availing Benefit to MSE.

### 5. DOCUMENTS TO BE SUBMITTED AS A PART OF PART – II: PRICED E-BID:

(a) BoQ/Priced Bid "in "XLS" format as per instructions provided.

### *Note*:

- 1. Bidder to execute supply as well as provide Supervisory Services for Commissioning at NRL Site and furnish their quote accordingly. Bidder to note that incase charges for Supervisory Services for Commissioning is indicated as 'Blank or ZERO' in BoQ, the same shall be considered as 'Free of Cost'.
- 2. Cost of supervision of erection, testing & commissioning for 10 man-days shall be considered for the evaluation. However during execution, payment shall be made on actual utilization of man-days.
- 3. Per Diem rate shall apply from the day the supervisory personnel reaches site and up to the day they leaves site. No payment shall be made for travel days / period.

#### 6. TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs):

This tender is guided by the Public Procurement Policy for Micro and Small Enterprises (MSEs) notified by the Government under the Micro, Small and Medium Enterprise Development Act, 2006, which came into effect from 1st April, 2012. The Ministry of MSME published an order known as Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 under which Micro and Small Enterprises (MSEs) shall be entitled for benefits, subject to terms and conditions as per ANNEXURE "X" enclosed.

7. **EVALUATION OF THE TENDER:** Tender shall be evaluated on 'Overall Lowest Offer Basis'.

### 8. **GENERAL**:

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self-certificate in this regard.
- Agencies submitting their bids shall not be on Holiday list of NRL or any other Oil PSE. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.
- iii) Consortium/Joint venture bids shall not be accepted.
- iv) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.

- v) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- vi) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
