1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Pre Qualification Criteria: (Must be submitted along with offer to be eligible for evaluation)

- 1.The bidder shall be OEM or authorized dealer of OEM for the Offered make of Photoionization (PID) Type Volatile Organic Compound (VOC) Detector. In case of authorised dealer, valid authorisation from the OEM shall be submitted along with the offer.
- 2.The bidder should have supplied the offered VOC (PID) detector in any Hydrocarbon Refinery/Refinery Te rminal/Petrochemicals/Hydrocarbon Gas Processing Industry/Fertilizer industries in India in last 10 years to be reckoned from the date of NIT.

The following documents shall be submitted by the bidder in support of the PQC.

i. Purchase Order Copy

ii. Job completion certificate/Commissioning report/MOM duly signed by EIC/client certifying successful commissioning of the VOC detectors. (In case of authorised dealer, the relevant documents from the OEM shall also suffice the requirement.)

Payment terms:

Payment will be made only after successful Certification from NRL EIC, in the following steps.

a) For Supply: 80% payment within 30 days from the date of receipt and acceptance of materials at site. The balance 20% amount on successful commissioning.

Note: Balance 20% payment against material supply can also be claimed on submission BG of equivalent a mount if installation & commissioning is delayed by more than 6 months from the date of receipt and acce ptance of complete materials at NRL site with BG validity till expiry of warranty period plus additional 3 months claim period.

- b) <u>For Service</u>: 100% after successful completion of installation & commissioning against submitted invoice duly certified by NRL Engineer-in-charge.
- c) <u>Half Yearly calibration service:</u> 100% after successful completion calibration service against submitted i nvoice duly certified by NRL Engineer-in-charge.

VENDOR SCOPE OF WORK:

- a) Selection of material as per NRL's Technical specification of requirements given
- b) Submission of document & QA plan for approval.
- c) Supply of all Materials including Packing, Forwarding and Transportation.
- d) Field testing, Commissioning & Calibration of detector by vendor engineer

3. Scope of Supply

Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

- exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to gualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
