Numaligarh Refinery Limited (NRL) invites e-bids from competent and experienced Indian manufacturer for the following under two bid system (Part-I: Techno-commercial part and Part-II: Price Part) with sound technical and financial capabilities fulfilling the Pre-Qualification Criteria (PQC) of the tender document.

2. **SUBMISSION OF E-BID:**

The E-Bid should be prepared in Two Parts as per the following details.

- i) PART – I: Techno-commercial / Unpriced Bid
- ii) PART - II : Price Bid

Note:

- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- v) **Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.**

3. **PRE-QUALIFICATION CRITERIA (PQC):**

- (i) Vendor must be a manufacturer of FRP/ PP moulded tanks for storage of acid/ alkali. Credentials in support of above to be submitted along with the offer.
- (ii) Vendor must have experience of supplying and successful commissioning of minimum 50 KL or above capacity FRP/ PP moulded tanks in the last 10 years to be reckoned from the final bid due date. PO copies in support of the same to be submitted along with the offer.

NOTE: The intending bidders shall have to furnish proof of their pre-qualification along with their Un-priced Techno-commercial bid. Pre-qualification Criteria will be checked at the time of techno-commercial evaluation of the offer. Bidders are to know that no further communication will be done to ascertain their prequalification. The offers with incomplete /irrelevant documents / anomalies may be straightway rejected without any communication.

4. **DOCUMENTS TO BE UPLOADED AS A PART OF PART – I: TECHNO-COMMERCIAL / UNPRICED E-BID:**

- a) Documents in support of PQC.
- b) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. The commercial terms & conditions should not be repeated in the offer.
- c) Technical Documents duly signed & stamped.
- d) Vendor Details as per Format enclosed.
- e) In case bidder is Micro & Small Enterprise (MSE), EM-II Certificate & Indemnity Bond as per clause no. 7 of NIT below for availing Benefit to MSE.

5. **DOCUMENTS TO BE SUBMITTED AS A PART OF PART – II: PRICED E-BID:**

- (a) Price to be quoted in BoQ “in "XLS" format as per instructions provided.

6. **EVALUATION OF THE TENDER:** Tender shall be evaluated on ‘**Item wise Lowest Offer Basis**’. Items to be considered for evaluation on 'Item wise Lowest Offer basis' are provided below:

- *Item-1 consists of supply of Horizontal Storage Tank (sl. no. 10 of BoQ) plus their Installation & Commissioning charge (sl. no. 20 of BoQ)*
- *Item-2 consists of supply of Vertical Storage Tank (sl. no. 30 of BoQ) plus their Installation & Commissioning charge (sl. no. 40 of BoQ)*

Note: In order to consider bidder’s offer for any of the above items, they need to quote price for both supply and corresponding Installation & Commissioning charge of that item in the BoQ.

7. **TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs):**

This tender is guided by the Public Procurement Policy for Micro and Small Enterprises (MSEs) notified by the Government under the Micro, Small and Medium Enterprise Development Act, 2006, which came into effect from 1st April, 2012. The Ministry of MSME published an order known as Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 under which Micro and Small Enterprises (MSEs) shall be entitled for benefits, subject to terms and conditions as per ANNEXURE “X” enclosed.

8. **GENERAL:**

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self certificate in this regard.
- ii) Agencies submitting their bids shall not be on Holiday list of NRL.
- iii) Consortium/Joint venture bids shall not be accepted.
- iv) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- v) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.

- vi) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
