BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

- 1. The bidder must have Experiences of executing contract value of <u>similar work*</u> completed during last 10 years ending last month i.e. 31.07.2017 as follows:
 - One completed similar work costing not less than **Rs.10.65 lakhs**, or
 - Two completed similar works costing not less than **Rs.8.52 lakhs** each, or
 - Three completed similar works costing not less than **Rs. 6.39 Lakhs** each.

*Similar Works: Pre-Qualification criteria - Technical:

1) The bidder shall be proficient in overhauling /providing commissioning assistance for API 618 Reciprocating Compressors of minimum 4HF/3 or similar higher Frame sizes with operating pressure of 160Kg/Cm2 or above and handling Hydrocarbon in any Industry.

Documentary evidence of any past references along with work order copy and work completion certificate shall be submitted with the bid.

The bidder shall also submit detail information of compressor frame size, operating pressure and service against the submitted work order copy. If such information is not appearing in the Work order, the same shall be submitted in separate sheet mentioning the Work order no. and duly vetted by the E-I-C.

2) Party shall be in possession of minimum manpower as required in this contract in the company payroll. Qualification and experience of the requisite manpower shall be as per Sl. No 13 of "other special terms and conditions" of contract (Part B under technical specification in the document Annexure A - Scope of work for ARC of recip compressor.docx).

Note:

- (i) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof (ending last day of the month i.e. 31.07.2017).
- (ii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall from the basis for considering experience and value of work executed under the private organization.
- 2. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least Rs. 6.39 lacs. The bidder must submit copy(ies) financial documents Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

- 3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
 - i. Provident Fund Registration Number.
 - ii. ESI registration number.
 - iii. Income Tax PAN Number.
 - iv. GST Registration Number.
- 4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
