Two parts bid **ONLINE (E-tender)** item rate offers requested from competent contractors for following work:

Name of Work:	Annual Rate Contract for Miscellaneous Civil works for Refinery & NRMT.

BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

1. The bidder must have Experiences of executing contract value of similar work* completed during last 10 years ending last month i.e. 31.07.2017 as follows:
 - One completed similar work costing not less than **Rs.75.15 lakhs**, or
 - Two completed similar works costing not less than **Rs.60.12 lakhs** each, or
 - Three completed similar works costing not less than **Rs.45.09 lakhs** each.

***Similar Works :**

- i. *The bidders should have experience of Any civil construction / Maintenance works but excluding jobs which is related to only grass cutting or drain cleaning or only manpower supply or only earth works or only painting works.*
- ii. *Contractor have to submit an undertaking regarding possession of drilling machine, welding machine, grinding machine, gas cutter, mixture machine (02 nos), vibrator(02 nos - 25 mm and 40 mm), glass & tiles cutter and other related tools & tackles required for civil construction / maintenance works of building and plant.*

Note:

Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year (ending last day of the month, proceeding the month in which bids are invited).

- (i) **Bidders should duly seal & signed the integrity Pact. Bidder's failure to return the Integrity pact duly signed shall result in the bid not being considered for evaluation.**
 - (ii) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof (ending last day of the month i.e. 31.07.2017).
 - (iii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall form the basis for considering experience and value of work executed under the private organization.
2. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs.45.09 lacs**. The bidder must submit copy(ies) financial documents – Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.
 3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
 - i. Provident Fund Registration Number.
 - ii. ESI registration number.
 - iii. Income Tax PAN Number.
 - iv. GST Registration Number.

4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. **Accordingly, the bidder shall submit a self declaration as per format enclosed with Tender Document.** It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
