**BRIEF SCOPE OF WORK:** As detailed in Tender Document, Special Terms & Conditions & BOQ.

#### **BID QUALIFICATION CRITERIA:**

- The intending bidders for above tender should meet the qualifications as given below:
   Past Experience of having successfully completed similar works during last 10 years ending last month should be either of the following:
  - > Three similar completed works costing not less than Rs. 35.55 Lakhs each, or
  - > Two similar completed works costing not less than Rs. 47.41 Lakhs each, or
  - ➤ One similar completed work costing Rs. 59.26 Lakhs.

\*Similar Works: The minimum Credentials / experience required for the Agency shall be as follows:

(i) Agency shall be an "EPC" i.e. Engineering, Procurement, and Construction Organization with capability to mobilize experts as mentioned above with minimum graduate engineering degree in streams i.e Metallurgical, Civil, Chemical, Mechanical engineering with minimum 10 (Ten) years' of experience in providing services to petroleum refinery in providing consultancy service to oil Refinery in mitigation Inspection and Maintenance issues related to static equipment.

(OR)

Agency shall be able to mobilize experts' i.e retired / present Management cadets / experts with sound health from different organizations like – Engineers India Limited, Shell Global, Bechtel Corporation, Tehhnip etc. i.e "EPC" - Engineering, Procurement, and Construction Organization having experience of providing consultancy service to oil Refinery in mitigation Inspection and Maintenance issues related to static equipment.

- (ii) Subject experts shall be conversant with codes and Standards ASME, ASTM, ANSI, API, AWS, NACE etc etc and Indian Standards, Codes and Rules.
- (iii) Subject experts shall also be conversant with refinery equipment design basis and processes to attend different plant related issues.

**Note:** (i) Bidders should duly seal & signed the integrity Pact. Bidder's failure to return the Integrity pact duly signed shall result in the bid not being considered for evaluation

(ii) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof

- (iii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall from the basis for considering experience and value of work executed under the private organization.
- 2. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs. 35.55 Lakhs.** The bidder must submit copy (ies) financial documents Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

### • OTHER REQUIREMENT:

It is to be noted that experience as main contractor will only be taken cognizance of for the purpose of assessing qualifying criteria. However, authorized sub-contractors under principal contractors can also be considered provided their works completion certificate is issued by the client organization in case of job executed elsewhere under PSUs, limited companies, Government Departments, Quasi government and autonomous bodies. However, in case of sub-contractors under contractors engaged by NRL, the works completion certificate issued by the main contractor will also be acceptable provided the same is endorsed in original by Engineer-in-charge of NRL in terms of job description and value.

For accepting experience as sub-contractor(s) or contractors under Private Organizations, in addition to the requisite certificates (letter of award and job completion certificate etc.)TDS certificate issued by principal contractor/private organization shall form the basis for considering experience and value of work executed.

- 3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
  - i. Provident Fund Registration Number.
  - ii. ESI registration number.
  - iii. Income Tax PAN Number.
  - iv. GST Registration Number.
- 4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
