If the buyer fails to lift the material as per **delivery schedule** as stated above, he shall be allowed to lift the material with application of Ground Rent Charges @ 0.1% (zero point one percent) of the value corresponding to non-lifted quantity of the lot per day w.e.f. 1st calendar day till 15th calendar days [after expiry of delivery schedule] unless stated otherwise.
- 16. After effecting payment, if the buyer fails to take delivery of material within the stipulated period, the buyer shall be treated as defaulter and shall have no claim over the lot thereafter. The concerned Department of NRL shall cancel/ terminate the sale order and delivery order issued to him and shall forfeit the amount of security deposit and balance payments paid by him, under intimation to him and STL as per clause 10(c) of "CONDITIONS OF E-AUCTION SALE"
- 17. NRL/STL shall not entertain any requests from the buyers regarding extension of payment period/delivery period as stipulated in the Sale Order.

The buyer shall be responsible for any damages that may be cause to the premises of NRL while dismantling, storage or removal of the lot(s) or items purchased by him and before removing such fire tender vehicles or items from NRL premises, the buyer shall be liable to pay the amount of damages assessed by NRL in this regard.
- 25. The buyers shall abide by and will be responsible to follow all the Labour Laws in respect of persons engaged by them. All personnel engaged by the buyer at site shall have to wear PPE (Personnel protection equipment) like boiler suit, helmet, safety shoe etc. as per direction of Fire & Safety Deptt. of NRL. NRL shall not be responsible for any claims raised by their personnel in respect of the e-auctions.
- 26. Sale Orders and Delivery Challans shall be made in the name of actual buyer only and no re-sale shall be permitted.
- 27. All the judicial proceedings, if any, in respect of any dispute(s) arising out of the e-auction shall be subject to the jurisdiction of court, where the concerned stores/ material is located.
