1. <u>EVALUATION & ORDER AWARD</u>:

❖ Evaluation will be done on "ITEM WISE LOWEST OFFER BASIS" and items are SPLITABLE.

2. PRE-QUALIFICATION CRITERIA:

- 1) Bidder must be either OEM or an authorized supplier of the OEM of the quoted models.
- 2) In any case, either OEM or authorized supplier(s) of OEM should quote.
- 3) The bidder should quote each line item from one OEM only. However, choosing different OEM for the different line items is allowed.
- 4) For the workstations, OEM of the quoted items must fall under top 3 manufacturers in the global workstation shipment.
- 5) For the workstations and AIO desktops, bidder should only quote models from OEM who have technical support center and spare part availability in North-east India, preferably at Jorhat or Guwahati.
- 6) Bidder must mention the name/address of OEM authorized service centers in North-East India, of the quoted models, in the technical bid.
- 7) Bidder must ensure next business day onsite support for the workstations and AIO desktops and defective parts replacement does not take more than 3 business days, after call logging.
- 8) Bidder must mention the model name of the quoted items and complete hardware component details in the technical bid.
 - Bidder must ensure that support and spare parts (same or compatible and with equivalent specification) of the quoted items will be available in the next 5 years. In case spare part unavailability due to some reason, bidder must ensure provision of standby equipments with equivalent configuration in place of the failed ones, within 7 days after call logging. Confirmation of the same from OEM/OEM authorized service partner is to be included in the technical bid.

SPECIAL NOTE TO THE BIDDERS:

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader/dealer.

(a) BoQ/Priced Bid "in "XLS" format as per instructions provided.

5. GENERAL:

- i) Consortium/Joint venture bids shall not be accepted.
- ii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iii) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
