1. EVALUATION & ORDER AWARD:

- ❖ Evaluation will be done on “OVERALL LOWEST OFFER BASIS” and the items are NOT SPLITABLE. As such, bidder has to quote for all items as per BOQ otherwise their offer shall not be considered for evaluation.

2. PRE-QUALIFICATION CRITERIA:

- a) Bidder must be a Manufacturer (OEM) or their Authorised Dealer of offered item. In case of authorised dealer, valid dealership/ authorisation certificate of manufacturer to be submitted for quoted item.
- b) Party must have supplied LFO Fuzzy Belts to any industry in last 10 years ending date of enquiry. Party must submit a copy of purchase order as a proof to the same along with the offer.

SPECIAL NOTE TO THE BIDDERS:

- c) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- d) **The above mentioned requirement of prior turnover and prior experience will be relaxed if the bidder is Micro and Small Enterprise or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.**
- e) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- f) **Price preference for MSE Bidder:** The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.
