Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 2. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Bid Qualification Criteria:

Bidder must have prior experience in the supply of filter elements (Cartridge/Coalescer) for ap plication in hydrocarbon service in any Indian Crude oil Refinery/Petrochemicals. Relevant PO copies with Tax invoice/TPI IRN/LR copy shall be submitted with BID.

BIDDERS ARE TO NOTE THAT no further communication may be done to ascertain their pre-qualificatio n at the time of evaluation of bids. The offers with incomplete / irrelevant documents / anomalies may be s traightway rejected without any communication. Hence, bidders are informed to take utmost care while

submitting their pre-qualification documents, annexures, supporting documents etc and also, must clarify their doubts/deviations from NRL at least 01 week prior to Bid submission date.

PO copies submitted with BID, as per requirement of technical and financial criterion, shall only be considered for evaluation purpose. Post closing of BID, no new PO copies shall be considered as per Govt procure ment guideline.

- 3. Cartridge shall be interchangeable to the existing filters in terms of dimension and metallurgy, party shall stand guarantee for this in line with guarantee clause as mentioned in GPC.
- 4. Dimensional drawings conforming to drawing provided with tender are to be submitted by vendor alo

ng with QAP for acceptance by NRL prior to manufacturing of the items. If any other technical details a re desired, the party may visit NRL plant for further data collection as per requirement. However, such requirement may be clarified before submission of BID.

- 5. All raw materials and their source shall be traceable with source of origin and material test certificates as per required specification.
- 6. Vendor shall develop their Quality Assurance Plan (QAP) in line with technical specifications mentione d for each item covering all necessary tests to meet quality conformance, filtration efficiency as per a pplicable procedure & standards along with other necessary tests for Cartridge filters. Accordingly, sta ge wise inspection by TPI (as applicable) shall be included in QAP and to submit for approval by NRL.
- 7. TPI shall be done through any of the following agencies SGS India Pvt Ltd/ TUV SUD South Asia Pvt Lt d/Bureau Veritas India Pvt Ltd/TUV India Pvt Ltd/Certification Engineers International Ltd/IR Class Syste ms and Solutions Ltd. For any other TPI agency, prior approval must be taken from NRL.
- 8. All correspondence with TPI agency for inspection of items shall also be communicated to NRL. Details of TPIA Inspector and contact details (valid email and mobile number of Inspector) to be shared with N RL so that NRL may contact Inspector, if necessary for validation/clarification.
- 9. TPIA shall issue inspection report with evidence of inspection at Vendor's work and release note on th eir letterhead. All the documents (TPIA endorsed) along with original inspection report and release not e shall be furnished with supply.
- 10. **Pre dispatch clearance** shall be issued by NRL after review of Inspection release note, test reports and certificates. Vendor to note the same and act proactively to dispatch and deliver the items on or before CDD.
- 11. **Final inspection** shall be done by NRL end user after the items are received at NRL warehouse and if any deviations are observed, NRL reserves the right to reject the items with due intimation to the vend or. The rejected items have to be replaced by the vendor free of cost.
- 12. Packing & Forwarding: The supplied items shall be properly packed and tagged with their respective NRL Item codes and details for safekeeping and identification of items. Each items shall be packed as per standard packing to protect filter from dust, moisture, foreign particles etc.
- 13. **Delivery period** shall be max 8 weeks from the date of placement of PO (Including the time for QAP & Drawing approval of approx. 6-8days).

14. Documents to be provided with material supply:

- a) Inspection release note by TPIA with supporting quality assurance dossiers
- b) Material test certificates of filter element components
- c) Fitment & interchangeability certificate for the supplied item with existing filter element
- d) Guarantee/Warrantee certificate as per tender provision. In case, Bidder being a dealer, guarantee/w arrantee certificate shall be validated from their principal.
- e) Storage instructions and shelf life certificate

- 15. Post order, Vendor may intimate NRL about delivery schedule and key contact details with stage wise time span for various activities/ division of responsibilities i.e. particularly timeline for QAP & drawing a pproval, dispatch clearance etc.
- 16. All other terms and conditions shall be guided by NRL GPC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
