- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

EVALUATION OF TENDER:

The items shall be evaluated on 'Overall Lowest Offer Basis'.

Pre-Qualification Criteria: The Technical PQC is proposed as follows:

Past track records of supply of software or software modules (that includes grap hical applications of Isometric Drawing for piping) along with training, implemen tation, customization in the last 5 years. Documentary evidance is to be submitted.

BIDDERS ARE TO NOTE THAT no further communication may be done to ascertain their pre-qualificatio n at the time of evaluation of bids. The offers with incomplete / irrelevant documents / anomalies may be s traightway rejected without any communication. Hence, bidders are informed to take utmost care while su bmitting their pre-qualification documents, annexures, supporting documents etc and also, must clarify their doubts/deviations from NRL at least 01 week prior to Bid submission date.

PO copies submitted with BID, as per requirement of technical and financial criterion, shall only be considered for evaluation purpose. Post closing of BID, no new PO copies shall be considered as per Govt procurement guideline.

TRANSPORTATION:

Delivery of the software, installation and Training to be provided is at NRL site and the transportation cost in this regard is under supplier's scope.

Payment Term:

100% payment within 30 days from the date of receipt and acceptance of materials at site.

Note: Bidders to note that NRL shall release all payments through e-payment mode (RTGS / NEFT) only and not through any other mode.

An amount equivalent to the extent of eligible Input Tax Credit (ITC) available to NRL on each invoice shall be released only upon reflection of corresponding invoice and Input Tax Credit details in G STR-2B report relating to NRL in GST portal. In other words, GST component eligible for Input Tax Credit, of any invoice shall be withheld till such time same is reflected in GSTR-2B.

Govt. has reduced the aggregate turnover for applicability of E-invoices from earlier limit Rs.20 cr ores to Rs.10 crores, which will be effective from 1st Oct'2022. In view above, all concerns are req uested to raise only E-invoice to NRL with all requisite details like IRN, QR code etc. Non-complied i nvoices shall not be accepted for further processing.

PERFORMANCE BANK GUARANTEE (PBG): Required for 24 months.

GUARANTEE/ WARRANTY:

Materials shall be guaranteed against manufacturing defects, materials, workmanship and design for a period of 12 months from the date of commissioning or 24 months from the date of last disp atch whichever is earlier. Warranty for replacement of material/ accessories should be provided fr

ee of charges at our premises. The above guarantee/warranty will be without prejudice to the certificate of inspection or material receipt note issued by us in respect of the materials.

CONTRACTUAL DELIVERY SCHEDULE::

Delivery period shall be max 4 weeks from the date of placement of PO.

STANDARD PRICE REDUCTION CLAUSE FOR DELAYED DELIVERY: In case of delay in executi on of the order, NRL may at its option, recover from the bidder price reduction of 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 5% of the total order value of goods.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
