3. Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.
4. The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
5. Buyer Added text based ATC clauses

Pre Qualification criteria:

1. The bidder must have supplied thermocouple shields for fired heaters to any industry handling hydrocarbon specially Refineries/Fertilizer/Petrochemical industries in last 5 (five) years ending last day of the previous month from the date of tender. Documentary evidence (s) substantiating the same shall be submitted by bidder in the form of relevant Purchase Order.

2. NRL reserves the right for independent verification of the references provided. Any negative feedback from any of the Clients on the performance and reliability shall lead to the rejection of the bid.

PQC will be Compulsory for all bidders including MSE/Stratups.
Relaxation of PTR norm for MSME & start up vendors shall be waived as the indented items are for public safety, health & critical operation.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
