### 1.0 Introduction

Numaligarh Refinery Limited, (NRL), is a Central Government Public Sector Undertaking and a subsidiary of Oil India Ltd. NRL has been operating a 3 MMTPA Refinery at Numaligarh in the District of Golaghat, Assam since the year 2000. NRL has embarked on an ambitious path to expand its refining capacity from current 3 MMTPA to 9 MMTPA at its existing location in Assam in next 4 years. The proposed tender is being lined up as apart of the Numaligarh Refinery Expansion Project to ensure proper storage of documents in the renovated documentation room through the installation of documentation storage system.

### 2.0 Brief Scope of Work:

As part of the Numaligarh Refinery Expansion Project, a large number of documents are being generated. A structured documentation cell in the basement area of Administration Building has been established and duly renovated. The subject tender is for procurement of a new documentation storage system for storage of documents generated during execution of NREP.

#### 3.0 Bidder Qualification Requirement (BQC):

Bidder(s) who meet all of the following criteria as specified in Clauses below shall be qualified for participating in this tender and shall submit supporting documents as detailed in the tender. Proposal submitted by bidders who qualify as per the following criteria shall be technically and commercially evaluated.

#### 3.1 Technical Criteria:

- 1. Bidder shall have experience of having successfully executed the Supply and installation of mobile shelving system/document repository system during the last 10 years ending on the last day of the month previous to one in which last date of original bid submission falls.
- 2. Bidder, in case of dealer or distributor of OEM, may submit the work experience of OEM.
- 3. Bidder/OEM should have ISO 9001, OHSAS 45001 and ISO 14001 Certifications.
- 4. Bidder/OEM should have a branch office and dedicated team in the state of consignee's location, so that any issues related to the document repository system can be addressed within forty eight (48) hours by visiting the site physically.
- 5. Both Manufacturer and their authorised dealer cannot bid simultaneously in this tender. If both of Manufacturer and its authorised dealer participate in this tender, then the offer from Manufacturer only shall be considered for further evaluation.

#### Notes:

- 1. Relevant work order copies and completion certificates are to be enclosed with offer. In absence of completion certificate, the bidder may submit copy of GST invoice and proof of payment.
- 2. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and thereafter at @0.58% for every completed month ending last day of the month proceeding the month inwhich last date of original bid submission falls.
- 3. It is to be noted that experience as main contractor will only be taken cognizance of for the purpose of assessing qualifying criteria. However, authorized sub-contractors under principal contractors can also be considered provided their works completion certificate is issued by the client organization in case of job executed elsewhere under PSUs, limited companies, Government Departments, Quasi government andautonomous bodies. However, in case of sub-contractors under contractors engaged by NRL, the works completion certificate issued by the main contractor will also be acceptable provided the same is endorsed inoriginal by Engineer-in-charge of NRL in terms of job description and value.
- **4.** Proof of being OEM or authorized dealer with validity as on the date of submission of offer to be enclosed with the technical bid. In case validity of the authorization from manufacturer/OEM expires before placement of order, bidder

shall obtain necessary validity, else offer shall not be considered for order.

- 5. Bidders are requested to confirm their valid GSTIN/UIN along with the Bid Document, with a copy of the relevant certificates. NRL at its discretion may not consider the bidder's offer for further evaluation if the GSTIN/UIN is not valid/active. Any misinterpretation or misinformation with respect to GSTIN/UIN may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.
- 6. A Job executed by a Bidder for its own plant/ project cannot be considered as experience for the purpose of meeting BQC of this Tender Document. However, jobs executed by Subsidiary/Fellow subsidiary / Holding company will be considered as experience for the purpose of meeting BQC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/Fellow subsidiary/ Holding company. Such Bidders to submit these documents in addition to the documents specified to meet BQC.
- 7. Bids from Consortium and Joint Venture Company shall not be accepted.
- 8. Bids shall be liable for rejection without any notice to the bidder in case of non-submission of the following documents.
  - i) Income Tax / GST TDS Certificate from the client / proof of TDS, etc. for authentication of doing such jobs in case bidder submits experience of similar jobs under private limited company.
  - ii) In case of the job is a part of composite work contract, then the bidder shall have to furnish documents certified by the client about the value for the portion of such "similar job".

### 3.2 Commercial Criteria: Past Experience

The Bidder shall have experience of having successfully executed \*similar works during the last 10 years ending on the last day of the month previous to one in which last date of original bid submission falls, meeting any one of the following options:

#### **Additional Note:**

- The bidder must submit copy (ies) financial documents Trading and P/L account(s) along with the unpriced bid in support of the above criteria.
- In case audited balance sheets and profit and loss account for the immediate preceding financial year is not available for bid closing date up to 30th September, the Bidder has an option to submit the audited balance sheets and profit & loss account of the 3 (three) previous years immediately prior to the last financial year.
- However, for bid closing date after 30<sup>th</sup> September, the bidder has to compulsorily submit the audited balance sheets and profit and loss account for the immediate 3 (three) preceding financial years, for evaluation and his qualification with respect to financial criteria. In any case the date (i.e. the financial period closing date) of the immediate previous year's audited annual accounts should not be older than 18 (eighteen) months from the bid due date.
- Audited Annual Report / financial statements needs to be accompanied with UDIN number, which is mandatory from July 2019 onwards. Any Financial Report which is issued after July 2019 onwards without UDIN shall not be considered for evaluation.

### 4.0 Documents required to be submitted in support of BQC

- **4.1** Bidder should submit documentary evidence to support the references provided and fulfilling the Bidder's Qualifying Criteria (BQC) as mentioned under Clause 3.0 herein above.
- **4.2** Bidder/OEM must provide Design calculation in support of their design to ensure safety & stability along with offer.
- **4.3** Bidder/OEM must provide Quality Assurance Plan (QAP) along with offer.
- **4.4** Raw material certificate from source has to be submitted, if selected as qualified, along with supply of materials. Sample of similar certificate to be provided along with offer.
- **4.5** Design certificate from a reputed organization/institution such as an Indian Institute of Technology or any qualified person/ department who is associated with any reputed organization/institution/ university has to be submitted, if selected as qualified, along with materials supply. Sample of similar certificate to be provided along with offer.
- **4.6** Test reports in favour of load bearing capacity, powder coating have to be submitted along with materials supplied.
- **4.7** Bidder/OEM should submit paint manufacturer's certificate along with offer.
- **4.8** Bidder/OEM should submit their own technical specifications to justify their offering inline to tender specifications.
- **4.9** NRL may ask for brochures/images/videos of the product/system for the requirement as mentioned in tender document
- **4.10** The following are the minimum documents required:
  - 4.2.1 Relevant documents as a proof of experience (relevant work orders / contract agreement /extracts/ experience certificate from authorized officials of PSU or Government Agencies, reputed private sectors).
  - 4.2.2 The Bidder shall ensure submission of complete authentic information / documentation along with the bid.
  - 4.2.3 NRL reserves the right to directly interact with the Bidder's clients to verify the relevant documentation and the Bidder will render assistance in facilitating the same.
  - 4.2.4 All documents furnished by the bidder in support of meeting the PQC (including MSE Certificate) shall be submitted/uploaded in a separate folder titled "Documents towards PQC", duly signed and stamped by the bidder (in case of proprietorship firm) or "Power of Attorney" holder in case of Partnership /firm/Company. Copy of such "Power of Attorney" shall also be furnished with the unpriced bid.
- **4.11** In absence of such documents, NRL reserves the right to reject the Bid without making any reference to the Bidder or assigning any reason what-so-ever.
- **4.12** All documents furnished by the bidder in support of meeting the PQC (including MSE Certificate) shall be submitted/uploaded in a separate folder titled "Documents towards PQC", duly signed and stamped by the bidder (in case of proprietorship firm) or "Power of Attorney" holder in case of Partnership /firm/Company.Copy of such "Power of Attorney" shall also be furnished with the unpriced bid.
- **4.13** Bidders on "Holiday List of/debarred from business dealings by" NRL/Oil PSUs /MOP&NG shall not be considered for evaluation and ordering.

- **4.14** NRL decision on any matter regarding short listing of bidders shall be final.
- 4.15 Submission of authentic documents is the prime responsibility of the Bidder. However, NRL reserves the right of getting the document cross verified, at their discretion from the document issuing authority. Bidder shall also facilitate such verification/ authentication of BQC documents and in case the documents remain unauthenticated till the given timeline, NRL reserves the right to reject such bid.
- **4.16** NRL reserves the right to complete the evaluation based on the details furnished (without seeking any additional information) and / or in-house data, survey or otherwise.

### 5.0 Earnest Money Deposit:

- **5.1** As mentioned earlier, the bidders shall submit "Bid Security Declaration" as per format attached (Annexure B to NIT).
- **5.2** EMD exemption will be applicable only for domestic vendors/ bidders only. The same is not applicable for foreign bidders.`
- 5.3 This clause shall override the respective clauses written elsewhere in the subject tender document.

### 6.0 Security Deposit/ Contract Performance Bank Guarantee (CPBG):

- **6.1** In line with Department of Public Enterprises (DPE)'s letter no. DPE/7(4)/2017-Fin. (Part I) dated 19th Nov' 2020, the rate of contract performance bank guarantee/ security deposit is hereby reduced to 3% of the value of contract.
- **6.2** This reduction in the rate of contract performance bank guarantee (CPBG)/ security deposit is applicable only for domestic vendors/ bidders. The same is not applicable for foreign bidders.
- **6.3** This clause shall override the respective clauses written elsewhere in the subject tender document.
- **6.4** The security deposit / CPBG shall be released after completion of the job in all respects.

#### 7.0 Time Schedule:

The time schedule for completion of the job as per scope of work shall be 14 (fourteen) weeks from the date of site handover.

**8.0** Bid Validity: Validity of bid shall be 4 (Four) months from the final Bid Due Date.

Online Bids are received only on CPPP Portal website <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.

#### 10.0 GENERAL:

- 10.1 The bidders shall give a declaration that the bidder shall not be under liquidation, court receivership or similar proceeding and their business is not banned by NRL, MOPNG or any OIL PSUs.
- 10.2 The bidders who are on Holiday / Negative list of NRL as on due date of submission of bid / during the process of evaluation of the Techno commercial bids, the offers of such bidders shall not be considered for bid opening / evaluation / Award. If the bidding document were issued inadvertently / downloaded from website, offers submitted by such bidders shall also be not considered for bid opening / evaluation/ award.
- 10.3 NRL will not be responsible or liable for cost incurred in preparation, submission & delivery of bids, regardless of the conduct or outcome of the bidding process.
- 10.4 In case any Bidder is found to be involved in cartel formation, his Bid will not be considered for evaluation / placement of order. Such Bidder will also be debarred from bidding in future.

Appendix-A

#### **Instructions for Online Bid Submission**

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL: <a href="https://eprocure.gov.in">https://eprocure.gov.in</a>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>.

#### **REGISTRATION**

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online Bidder Enrolment" on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

#### **SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS

1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.

- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the priced bid have been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- 4) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 5) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 6) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 7) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 8) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

### Special Instructions to the Bidders for the e-submission of the bids online through e-Procurement Portal:

- Bidder should do Online Enrolment in this Portal using the option Click Here to enrol available in the Home Page. Then the Digital Signature enrolment has to be done with the e-token, after logging into the portal. The e-token may be obtained from one of the authorized Certifying Authorities such as eMudhraCA/GNFC/IDRBT /MTNLTrustline/SafeScrpt/TCS.
- Bidder then logs into the portal giving user id / password chosen during enrolment.
- The e-token that is registered should be used by the bidder and should not be misused by others.
- DSC once mapped to an account cannot be remapped to any other account. It can only be Inactivated.
- The Bidders can update well in advance, the documents such as certificates, purchase order details etc., under
  My Documents option and these can be selected as per tender requirements and then attached along with bid
  documents during bid submission. This will ensure lesser upload of bid documents.
- After downloading / getting the tender schedules, the Bidder should go through them carefully and then submit the documents as per the tender document, otherwise, the bid will be rejected.
- The BOQ template must not be modified/ replaced by the bidder and the same should be uploaded after filling the relevant columns, else the bidder is liable to be rejected for that tender. Bidders are allowed to enter the Bidder Name and Values only.

In order to reduce the file size, bidders are suggested to scan the documents in 75-100 DPI so that the clarity is maintained and also the size of file also gets reduced. This will help in quick uploading even at very low bandwidth speeds.
- It is important to note that, the bidder has to Click on the Freeze Bid Button, to ensure that he/she completes the Bid Submission Process. Bids which are not Frozen are considered as Incomplete/Invalid bids and are not considered for evaluation purposes.
- In case of Offline payments, the details of the Earnest Money Deposit(EMD) document submitted physically to the Department and the scanned copies furnished at the time of bid submission online should be the same otherwise the Tender will be summarily rejected
- The **Tender Inviting Authority (TIA)** will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders due to local issues.

- The bidder may submit the bid documents online mode only, through this portal. Offline documents will not be handled through this system.
- At the time of freezing the bid, the e-Procurement system will give a successful bid updating message after uploading all the bid documents submitted and then a bid summary will be shown with the bid no, date & time of submission of the bid with all other relevant details. The documents submitted by the bidders will be digitally signed using the e-token of the bidder and then submitted.
- After the bid submission, the bid summary has to be printed and kept as an acknowledgement as a token of the submission of the bid. The bid summary will act as a proof of bid submission for a tender floated and will also act as an entry point to participate in the bid opening event.
- Successful bid submission from the system means, the bids as uploaded by the bidder is received and stored in the system. System does not certify for its correctness.
- The bidder should see that the bid documents submitted should be free from virus and if the documents could not be opened, due to virus, during tender opening, the bid is liable to be rejected
- The time that is displayed from the server clock at the top of the tender Portal, will be valid for all actions of requesting bid submission, bid opening etc., in the e-Procurement portal. The Time followed in this portal is as per Indian Standard Time (IST) which is GMT+5:30. The bidders should adhere to this time during bid submission.
- All the data being entered by the bidders would be encrypted at the client end, and the software uses PKI encryption techniques to ensure the secrecy of the data. The data entered will not be viewable by unauthorized persons during bid submission and not viewable by any one until the time of bid opening. Overall, the submitted bid documents become readable only after the tender opening by the authorized individual.
- During transmission of bid document, the confidentiality of the bids is maintained since the data is transferred over secured Socket Layer (SSL) with 256 bit encryption technology. Data encryption of sensitive fields is also done.
- The bidders are requested to submit the bids through online e-Procurement system to the TIA well before the bid submission end date and time (as per Server System Clock).

**Appendix-C** 

#### **INSTRUCTIONS FOR MSE BIDDERS**

- a) As per Public Procurement Policy for Micro & Small Enterprises (MSEs) Order, 2012 issued vide Gazette Notification dated 23.03.2012 by Ministry of Micro, Small and Medium Enterprises of Govt. of India and Gazette Notification no. 2119(E) dated 26.06.2020 in supersession of Gazette Notification no. 1702(E) dated 01.06.2020, Micro and Small **Enterprises** (MSE's) must have UDYAM Registration Certificate (https://udyamregistration.gov.in) permitted by GOI w.e.f., 01.04.2021, to avail the benefits / preference available vide Public Procurement Policy MSEs Order, 2012.
- b) However, in line with the Ministry of Micro, Small and Medium Enterprises Notification dated 16<sup>th</sup> June, 2021 published in the Gazette of India, it is hereby informed to all MSE bidders that the existing enterprises registered prior to 30th June, 2020 can also submit valid Udyog Aadhar Memorandum (UAM) or Entrepreneurs Memorandum (EM Part-I) issued by competent authority as per MSME rule, in support of their identification as MSE bidder. Documentary evidence has to be submitted.
  - While evaluating the bids, Section A (Qualifying Criteria for MSE Bidder) of **Appendix I to SCC** will be considered in conjunction with the above.
- c) MSEs participating in the tender must submit the UDYAM Registration Certificate. Policy is meant for procurements of only goods produced and services rendered by MSEs. Stockist/Traders are excluded from the purview of public procurement policy.
- d) The UDYAM Registration Certificate must be valid as on close date of the tender.
- e) The MSEs who do not have the Udyam Registration Certificate as on close date of the tender, are not eligible for exemption / preference.
- f) UDYAM Registration Certificate shall be the sole registration document for qualifying as MSE. UAM and EM Part II Certificates issued by various bodies specified like NSIC, DIC, COIR Board, KVIC, KVIB, DHH, MSME etc. shall not be considered for qualification.
- g) In order for MSE owned by SC/ ST Entrepreneurs to qualify for benefits available under Public Procurement Policy for MSEs order 2012 to SC/ST entrepreneurs, the "Social Category" in Udyam Registration Certificate should state "SC" or "ST".
- h) If the Gender is clearly stated in UDYAM Registration, the same will be considered for evaluation and no other additional document will be required to qualify as Women owned MSE.
- i) The MSEs registered with UDYAM are exempted from payment of Earnest Money Deposit (EMD).
- j) Following vendors shall not get MSE related benefits:
  - i. MSEs registered as a Service Enterprise participating in a tender for supply of goods for which they are not registered.
  - ii. MSEs registered as Manufacturing Enterprise but participating in a tender for rendering services for which they are not registered
  - iii. The preference to MSEs is not applicable for works contracts where supply of goods not produced by the MSEs is also involved
- k) The value of Performance Bank Guarantee (PBG) shall be relaxed by 50% of the requirement as per tender terms in case of MSEs owned by SC/ST & Women entrepreneurs.
