OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Scope of Supply

Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

- 3. Bidder must have supplied minimum 01 (one) unit of the offered machine model in last 10(ten) years in India from bid closing date. The same must have been supplied to any Indian PSU company / Indian PSU su bsidiary/Indian Govt. Organization/Indian Refinery/Indian Petrochemicals. Purchase Order copy/ies as ment ioned above and subsequent commissioning certificates/invoice shall be submitted.
- 4. Bidder must have existing after sales customer support network in India specifically for the offered mach ine model. Contact details shall be provided.

NRL reserves the right for independent verification of the references provided. Any negative feedback fro many of the Clients on the performance and reliability shall lead to the rejection of the bid.
