Past Experience of having successfully completed similar works* during last 10 years ending 31.08.2016.

PAST EXPERIENCE

- Three similar completed works costing not less than Rs. 14.49 **Lakhs** each, or
- Two similar completed works costing not less than Rs. 19.32 **Lakhs** each, or
- One similar completed work costing Rs. 24.15 **Lakhs**.

***Similar Works:**

- Bidder should have experience in Industrial painting works on piping and structures at Refinery and Petrochemical units.
- To submit undertaking regarding owning of spay machines (1 nos), DFT meter machines with accessories (1 nos.), steel scaffolding materials for minimum 1000 sqm along with the documents.

Work order copies and Completion certificates shall form basis for proof of work experience.

The value of past experience shall be adjusted at a simple rate of **07%** for every completed year ending last day of the month, proceeding the month in which bids are invited.

*TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate) shall form the basis for considering experience and value of work executed under the private organization.

Agencies who are already blacklisted or against whom there is adverse report on committing criminal offence, their offers shall be rejected.

OTHERS: Following documents should be submitted along with the offer:

- The bidders must have PF registration, PAN number & PAN based Service Tax registration number.

NOTE:

Online Bids are received only on CPP Portal website <https://eprocure.gov.in/eprocure/app> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Also they can view the bid opening event online at their remote end. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt. They can also view the bid opening event online at their remote end.
