Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Up-keepment and sample handling contract for QC Laboratory at SMT
Tender No. & Date :	OC34000016/SAM dated 05.09.2022
Due Date of Submission:	Before 11.00 AM of 21.09.2022
Earnest Money Deposit:	Rs.21,000/-
Contract Period:	24 months from the date of site handover and extendable by another 12 months as per requirement of NRL.

PRE-QUALIFICATION CRITERIA:-

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

- **One** similar work costing not less than **Rs.20.55 Lakhs**
- **Two** similar works costing not less than **Rs.16.44 Lakhs each** and
- **Three** similar works costing not less than **Rs.12.33 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** Bidder should have prior experience in execution and successful completion of "Up- keepment and sample handling in laboratory or AMC nature of job (except civil nature of works) in PSU or Government Organization."

- In order to have day to day monitoring and managing the work, perform statutory formalities like PF, Labour License, Trade License, ESI, managing their workers and to deal with situation of emergency due to strike/ bandh call dharna etc, timely payment of wages and arrears; maintaining various registers as per the formats of respective departments and to produce the same during the visit of the officials for routine checking ; the bidder shall meet the following conditions:

The bidder should have an existing registered or branch office in Darjeeling or Jalpaiguri district with working office set up on the date of submission of bid. Trade license will be considered as a proof of the registered or branch office and will be subject to verification if required.

B) AVERAGE ANNUAL TURNOVER, of the last 3 financial years, shall be at least Rs.12.33 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three 3 financial years mentioned above refers to immediate 3 preceding financial years wherever the last bid submission date is after 30th Sept. In case of tenders having last bid submission date up to 30th September, and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the 3 years prior to preceding financial year will be considered. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
