in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Pre-qualification criteria of the bidder:

a)The bidder must be a reputed manufacturer of the material as per our spec. If the bidder is not a manufacturer of the material, the bidder must be an authorized dealer of the concern manufacturer. In this regard, copy of authorization certificate to be attached with the offer.

b) The bidder must provide references regarding supply of the material for Amine Treating Unit of other ref inery. The material shall be used for amine gas treating to remove H2S from sour gas stream of oil refiner y. The detail references including the copy of the purchase order to be attached with the offer. Minimum o ne reference of supply for amine treating unit of Indian Refinery is required.

Packing:

The material to be supplied in 200 kg (approx.) steel drums or HDPE drums in proper sealed condition. Any drums found in leaking/rusted condition shall not be accepted. Following should be clearly marked on each drum:

- a) Name of the material
- b) Trade name/code
- c) Gross wt. in Kg
- d) Net wt. in Kg.
- e) PO Number
- f) Lot no.
- g) Date of manufacture
- h) Name of Manufacturer
- i) Date of Expiry

Delivery period:

First Batch to be delivered at NRL site by within one month of placement of release order.

Second Batch to be delivered at NRL site after two months of delivery of first batch.

Payment Terms:

100% within 30 days of receipt and acceptance of materials at NRL site.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
