1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

5. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

Pre-Qualification Criteria:

The bidders who intend to participate in the tendering process shall meet the following minimum requirem ents and only such bidders shall be prequalified technically for further evaluation.

- a) The bidder shall be Original Equipment Manufacturer (OEM) or authorized representative of the OE M of the offered Drone (Unmanned Aerial Vehicle). In case the bidder is not the OEM of the offered Drone, a valid authorization certificate shall be issued by the OEM in the name of the bidder clearly stating that OEM shall provide necessary guaranty/warranty, after sales operation & maintenance support as and when required.
- b) The offered make of the drone (Unmanned Aerial Vehicle) shall be DGCA registered. The bidder shall submit documentary evidence along with offer for the same.

Payment Term:

- a) For Supply: 100% payment within 30 days from the date of completion of commissioning, testing & de monstration.
- **b) For Service**: 100% after successful completion of installation & commissioning against submitted invo ice duly certified by NRL Engineer-in-charge.
- c) **For Post warranty- AMC**: Pro rata on quarterly basis, against submitted RA bill invoices duly certified by NRL Engineer-In-Charge.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
