Highlights of Performance for the Quarter Jul-Sep'16

The Board has adopted the Accounts for the quarter ended 30th Sep'16 on 11th November'16. The major highlights of the quarter and the year to date are as under:

- Crude Throughput for the current quarter Jul-Sep'16 was 555.87 TMT (74.1%) as against 753.26 TMT (100.4%) of the corresponding quarter Jul-Sep'15 of the previous year. The lower throughput during current quarter Jul-Sep'16 in comparison to the corresponding quarter Jul-Sep'15 of the previous year (26.2%) was on account of refinery shut down during Sep'16.
- Product Sales for current quarter Jul-Sep'16 was 539.0 TMT was 21.22% lower when compared to the corresponding quarter Jul-Sep'15 of the previous year at 684.2 TMT. Lower sale is on account of refinery shut down during Sep'16.
- Revenue from Operations for the current quarter Jul-Sep'16 at ₹ 2,679.28 crores is 11.82% lower in comparison to the corresponding quarter Jul-Sep'15 of the previous year at ₹ 3,038.55 crores mainly due to lower sales.
- Net Profit / (loss) after Tax (PAT) for the current quarter Jul-Sep'16 was ₹ 354.43 crores is 31.49% higher in comparison with the corresponding quarter Jul-Sep'15 of the previous year at ₹ 269.55 crores. The higher profit is on account of better margins.
