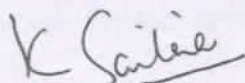

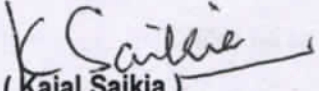

Q.No 1 How, could the eligible candidate came to know the result of interview that they faced at Kolkata on selection of dealer for Retail Outlet (Petrol Pump) at Hasimara and when?

Reply : Result was displayed in the notice board at NRL Kolkata Office on the day of interview after the interview process was completed. The selected candidate must have come to know from the notice board.

Q.No 2 What are the essential ingredients were needed at that point of time as a normal course of action after having been selected dealer in order to engage / or allow handling marketing of NRL brand product HSD, MS etc. through retail outlet i.e. (Petrol Pump) to be set out there according to Co's point of view and dealer's consent?

Reply : Some of the essential elements that need to be completed before starting sale of petroleum products from a Retail Outlets are-

- Proper plot of Land meeting all NHAI and other statutory norms.
- NOC from statutory authorities like District Magistrate, Pollution Control, Fire Service, Explosive etc.
- Trade license.
- Setting up facilities like sales Room, Storage Tanks, Dispensing Pumps, Driveway, Electricity etc.

Q.No 3 Who was supposed to do all the above mentioned works, whether it pertains to Co's end or on dealer on its own as per Co's direction and specification thereon?

Reply : It depends on the type of Retail Outlets. For an open category Retail Outlets under Company controlled, land is arranged by the Dealer and is leased to the company. All other facilities are provided by company.

Q.No 6 Was there any provision for security deposit on such dealership?

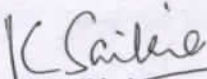
Reply : Yes, the dealer need to make a security deposit of Rs. 3 Lakhs to NRL.
