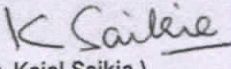

Reply: Numaligarh Refinery was conceptualized as one of the most Environment friendly Refineries in the country. Right from its inception, conscious efforts have been taken at every stage to preserve the environment and to attain the Excellency in Environment Management. A fully functional "Environment Cell" under guidance of Chief General Manager (Technical) is continuously working for controlling all kinds of pollution, improvement in environmental protection, monitoring, safe-guarding. Reporting of environmental activities / affairs to regulatory bodies are timely adhered without any deviation. All stipulated conditions of PCBA, CPCB and MoEF &CC are adhered and complied.

A proper solid waste management procedure is in place at Numaligarh Refinery to deal with storage / disposal of the solid wastes generated due to operational activities of refinery. Considerable amount of solid wastes are generated for the operation of refinery. To deal with the same, an environment friendly proper solid waste management system has been implemented. To address the above issues, NRL Management has delineated a solid waste management plan with the following objectives –

1. To protect human health and natural environment from the hazards posed by waste disposal.
2. To conserve energy and natural resources through waste recycling and recovery.
3. To reduce / eliminate, as far as possible the generation of solid wastes including hazardous wastes.
4. To segregate and proper storage of all kind wastes at the generation site itself.
5. To ensure proper management of solid wastes which protects the human health and the environment

Step to minimize waste generation/disposal -

In-built measures has been adopted to minimize, control of pollution and generation of wastes in all the units with proper segregation, collection and disposal system. Adequate segregation, collection and treatment facilities for waste water for centralized treatment has been provided to meet the stringent standards laid down in the latest MoEFCC Notification. An environmentally compatible management system for disposal of the ETP sludge through Secure Land Fill has been developed inside the refinery premises. Disposal of hazardous solid waste i.e. Chemical & Oily sludge generated in the ETP has been carried out through deep burial process in Secured Land Fill. The Secured Land Fill is continuously under operation in the Refinery premises itself. To cater the needs of future requirement another new Secured Land Fill with higher capacity of around 6000m³ has been constructed. Entire treated effluent is reused in the refinery in fire water network and gardening. Storm water is reused in cooling tower as cooling water make up as well as in fire water network for which withdrawal of fresh water from River has been reduced considerably.

Step to recovery of oil from sludge -

Oily sludge generated at different section of Effluent Treatment plant is collected in a sludge thickener through sludge collection system and from the thickener, floating oil with water is recycled back to the Inlet Receiving Sump (IRS) of ETP for further processing and recovery of oil. The thickened sludge from the bottom of the thickener is taken to the centrifuge feed sump for feeding to highly efficient Oily centrifuge through the feed pumps for recovering the absorbed oil from the sludge. By using the specially designed high efficient Oil centrifuge for this purpose, almost total oil is recovered from the sludge and is recycled to the slop oil system for reprocessing. The oil free cake from the centrifuge is kept in sealed drums which are then disposed off in the Secured Land Fill following proper procedure. For ease handling and operation, the Secured Land Fill has been divided into various cells separated by soil mounts. The waste is disposed off at these cells and compacted. The compacted waste is then covered by 15 cm soil layer after every day's operation which minimizes the chance of fire hazard, water percolation and odour problem.

Apart from the above systematic procedure, NRL has taken up a lot of advance & innovative initiatives in the management of Hazardous Waste Treatment and Disposal Facilities. Cleaning of tank bottom oily sludge is being done by adopting BLABO process, which is a close loop process and by which nearly 100% recovery of hydrocarbon is achieved. After Blabo process, whatever oily sludge generated is being mainly disposed off through selling to CPCB/PCBA recognized recyclers/ vendors / agencies. Whatever left out, disposed through Bioremediation process in a more scientific and efficient manner in the Refinery premises itself.

Disposal of Spent catalyst -

Spent catalysts are generally generated after a gap of 5/6 years when the catalyst required to replace in the various units of Refinery. After generation, the spent catalyst is kept in sealed drums at demarcated place for onward selling to CPCB/SPCB approved vendors with due intimation to PCBA and by following the stipulated guide lines/procedures.

Disposal of oily sludge through Bioremediation process -

Bioremediation is a process that uses naturally occurring microorganisms to transform harmful substances to nontoxic compounds. There are innumerable strains of microbes under basic categories of bacteria, yeast or fungi, which degrade oily sludge and waste water effluent sludge through digestion of harmful chemicals and compounds present in oily sludge and waste water effluent sludge into simpler, less toxic or non-toxic substances. These beneficial microbes break down a wide variety of organic (carbon-containing) compounds found in oily sludge and waste water effluent sludge to obtain energy for their growth. Many species of soil bacteria, for example, use petroleum hydrocarbons as a food/energy source, transforming them into harmless substances consisting mainly of carbon dioxide, water and fatty acids. Bioremediation exploits this natural process by promoting the growth of microbes that can effectively degrade specific contaminants and convert them to nontoxic by-products. There are two basic types of bioremediation - "Bio-stimulation" provides nutrients to the indigenous microbial populations. This promotes growth and increases metabolic activity that is used to degrade contaminants. The other is - "Bio augmentation", it introduces specific blends of microorganisms into a contaminated environment or into a bioreactor to initiate the bioremediation process, which increases the population of the fit to handle the bio-degradative process in the contaminated area.
