Relevant facts emerging from appeal:

RTI application filed on : 25.04.2022
PIO replied on : 24.05.2022
First Appeal filed on : 20.06.2022
First Appellate Order on : 15.07.2022
2ndAppeal/complaint received on : 05.12.2022

Information sought and background of the case:

The Appellant filed an RTI application dated 25.04.2022 seeking information on following points:-

"i). When the Vivekananda Kendra Numaligarh Refinery Hospital was established which is situated in the premises/ township of the Numaligarh Refinery?

ii). The name of the Management Committee/ Executive Body who manage/conduct the Vivekananda Kendra Numaligarh Refinery Hospital and the

names of the members of the said Body.

iii). The copy of the Deed of Agreement between the management of the Numaligarh Refinery Ltd. and the management of Vivekananda Kendra Numaligarh Refinery Hospital in connection with the management of Vivekananda Kendra Numaligarh Refinery Hospital.

iv). Total numbers of permanent employees and total numbers of contractual workers (skilled and unskilled) serving in the said Vivekananda Kendra Numaligarh Refinery Hospital.

Etc."

The CPIO vide letter dated 24.05.2022 replied as under:-

Point No. 1 to 9: Vivekananda Kendra Hospital is not a public authority under fie RTI Act 2005. Hence, we are not In a position to provide the information.

Dissatisfied with the response received from the CPIO, the Appellant filed a First Appeal dated 20.06.2022. The FAA vide order dated 15.07.2022 stated as under:-

"Q.N.1 VKNRL Hospital was established on 19 September, 1997.

Q.N.2 There is a coordination committee with members from Vivekananda Kendra Medical Research Foundation and NRL The members are

nominated by both the agencies from time to time.

Q.N.3 The VKNRL hospital is run by VKMRF. VKMRF is a charitable institution and has undertaken to providing services purely in consideration of its charitable disposition and not for profit or other financial consideration whatsoever for the furtherance of its charitable objects of providing medical benefits to society. The deed of agreement signed between VKMRF and NRL is a non-commercial document signed with a charitable institution and hence not provided as it does not serve any public purpose.

Q.N.4 NRL does not maintain list/ record of permanent employees or contract workers of Vivekananda Kendra Numaligarh Refinery Hospital.

Etc."

Aggrieved and dissatisfied, the Appellant approached the Commission with the instant Second Appeal.

Facts emerging in Course of Hearing:

Appellant: Present

Respondent: Col. Sakia, PIO

The Appellant stated that complete information has not been furnished by the PIO. He requested to direct the PIO to furnish the deed of agreement signed between VKMRF and NRL since the same should be place in public domain.

The Respondent stated that the point-wise information has been duly furnished to the Appellant from their official record. He stated that the deed of agreement signed between VKMRF and NRL is a non-commercial document signed with a charitable institution and hence not provided as it does not serve any public purpose.

Decision:

Commission, after perusal of case records and submissions made during hearing observes that information sought at point No. 3 of the RTI Application i.e. copy of the deed of agreement signed between VKMRF and NRL has denied by the PIO

without quoting any specific exemption clause as per provisions of RTI Act. In the given circumstances, the Commission directs the present PIO to furnish a copy of deed of agreement signed between VKMRF and NRL as sought by the Appellant, as available in their records, with regards to the instant RTI Application, to the Appellant, free of cost via speed post, within 30 days from the date of receipt of this order and accordingly compliance report to this effect be duly sent to the Commission by the PIO. In doing so PIO must make sure that information which is exempted from disclosure under RTI Act, 2005 must not be disclosed to the Appellant and same must be redacted under section 10 of the RTI Act, 2005 prior to the said disclosure. As regards the other points of the RTI Application, the Commission is of the considered opinion that an appropriate response has been furnished to the Appellant as per provisions of RTI Act. No further action lies.

Appeal is disposed of accordingly.



- Q.N.5 Whether the Vivekananda Kendra Numaligarh Refinery Hospital. Provides free treatment/ concessional treatment? If yes, to whom?
- Reply: Yes, to the economically poor families of the neighborhood.
- Q.N.6 The Annual Financial Assistance provided by the Numaligarh Refinery Ltd to the Vivekananda Kendra Numaligarh Refinery Hospital from the year 2011 to 2021 (as per the Annual Revenue Budget submitted by the management of the Vivekananda Kendra Numaligarh Refinery Hospital to the concerned authority of the Numaligarh Refinery Ltd.
- Reply: The annual financial assistance provided by NRL to VKNRLH for the years 2011-2021 is enclosed in Annexure I.
- Q.N.7 The total annual income of the Vivekananda Kendra Numaligarh Refinery Hospital from the year 2011 to 2021.
- Reply: VKNRLH is a non-commercial charitable institution which provides free and concessional treatment to the people of the neighborhood. Whatever income is generated by is adjusted against the deficit incurred and the deficit amount is provided by NRL as grant.
- Q.N.8 From the year 2011 to 2021 how many times the management of the Vivekananda Kendra Numaligarh Refinery Hospital submitted capital budget to the concerned authority of the Numaligarh Refinery Ltd.
- Reply: There is no mechanism of submitting capital budget by VKNRLH. Capital expenditures are incurred as and when required.
- Q.N.9 The names and amount/ rates of machineries / instruments / equipment's purchased by the concerned authority of the Vivekananda Kendra Numaligarh Refinery Hospital from the year 2011 to 2021.
- Reply: The names and amount/ rates of machineries / instruments/ equipment's purchased by VKNRLH is not available.

With the above, your appeal is hereby disposed-off.
