a	The final product shall be used only as a bio-fuel and not at all for human consumption.	Noted for compliance

(iv) Solvents shall be stored in a separate space specified with all safety measures. (v) proper earthing shall be provided in all the electrical equipment wherever solvent handling is done. (vi) Entire plant shall be flame proof. The solvent storage tanks storage tanks shall be provided with breadth valve to prevent losses.
