This has reference to your letter no. nil dated 01-06-2015 seeking information under RTI Act 2005. Please find below replies to the queries raised by you.

Q. No. 1. Whether Numaligarh Refinery Limited and Bharat Petroleum Corporation Limited are two separate companies established under the Company's Act of Govt. of India. Since which year Bharat Petroleum is associated as share holder of Numaligarh Refinery Limited. Presently, how much of the total share of Numaligarh Refinery Limited being held by Bharat Petroleum Corporation.

Reply: Numaligarh Refinery Limited (NRL) and Bharat Petroleum Corporation Limited (BPCL) are two separate independent companies as per Companies Act BPCL become a shareholder of NRL since 11-03-1996 and a holding company w.e.f. 31-03-2000. Presently BPCL are holding 61.65% equity stake in NRL.

Q. No. 2. Whether Bharat Petroleum Corporation Ltd was a share holder of Numaligarh Refinery Ltd when Numaligarh Refinery decided to start operation of its Retail Outlets ? And if, Bharat Petroleum was a share holder at that time then what was the percentage of share held by Bharat Petroleum during that time?

What was the expenditure incurred by Numaligarh Refinery Ltd for establishment of these Retail Outlets?

Under what terms and agreement Bharat Petroleum Corporation have taken over these Retail Outlets and how much is the amount paid thereof for these Retail Outlets?

Reply: Yes. 61.65% equity stake.

The expenditure incurred by Numaligarh refinery Ltd for establishment of Retail outlets is Rs. 155.82 Crores.

NRL has taken Board approval for handing over its Retail Outlets to BPCL in 2 phases in the year 2010 and again in the year 2012. After getting in principle approval from the Board, separate agreements have been entered into between NRL and BPCL for handing over the retail outlets. Further, a valuer had been appointed for valuation of the Retail Outlets. Based on valuation report, sales price was established.

Handing over of the Retail Outlets to BPCL is a lengthy process as lease assignment has to be transferred from NRL to BPCL. Currently, these lease assignment processes is going on and based on completion of the lease assignment, NRL is raising sales invoices on BPCL against which BPCL makes the payment.

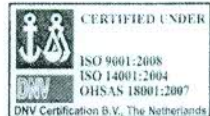
