Reply: Following are the sustainable initiatives undertaken by NRL to protect the environment:

- 1. Installation of Solar Power System in nearby school
 - NRL installed 2 KW Solar Power system in 7 nos. of nearby school.
 - Also installed 20 KW Solar Power system at DPS Numaligarh.
 - Executing agency: M/s C.H.S. Solution, Guwahati
 - Total amount allocated : Rs. 56.60 lacs
- 2. Installation of Solar Power Panel at NRL Administration building
 - Installed 100 KVA solar panel at NRL administration building
 - Executing agency: M/s Qubic Suntrach Energy Pvt. Ltd.
 - Total amount allocated : Rs. 128.00 lacs
- 3. Substitution of Naphtha with Natural Gas in its Gas Turbine Generator & Hydrogen Plant which has helped
 - Reduce operating cost, thereby improves Gross Refinery Margin.
 - Contributed towards higher Distillate Yield
 - Reduce green house gas emission.

- · Persistent reduction in Sulphur emission.

6. Ambient air monitoring

NRL has set up six nos. of air monitoring station in and around the vicinity of the refinery. These initiatives ensure that the natural habitat and the wild animals of Kaziranga National Park are not affected in any way by the impact of refinery emission.

7. Unique ground flare system

NRL installed a non-illuminating ground flare system. This was incorporated in order to avoid any adverse impact of the flare on animal in the Kaziranga National Park.

8. Waste Management of NRL in done as follows to conserve environment

- Tank bottom waste: Disposed off through bio remediation by applying oil zapper in the bio remediation site located inside the refinery.
- Oily sludge: Disposed off in secured landfill facility inside the refinery.
- Battery Waste: Disposed off through registered recyclers.

9. Installation of double seal I EFRT/IFRT tanks

As a step towards monitoring and control of Fugitive Emission and VOC recovery of the stored volatile liquids, installation of double seal in few IFRT/EFRT tanks located inside refinery & NRMT is in progress in phase wise manner. The job is executed by M/s Sai Tools, Maharastra, cost involvement is around Rs. 310.00 lacs.

10. Implemen of VOC Recovery System at ETP

Installation of VOC recovery system in Effluent Treatment Plant (ETP) is under implementation. The contractor is UEM, Noida and the cost involvement is 17.5 crores.
