Q. 1. How many tank trucks have been allotted under SOC since establishment of Numaligarh Refinery Limited? From which organization and in whose names have tank trucks have been allotted. Please give detailed information of the same. Presently, how many tank trucks are running and how many trucks have been stopped?

Reply : Since establishment of NRL, 170 tank trucks have been allotted to 170 transporters under Social Objective Category (SOC). The name of the above 170 SOC transporters along with their address is attached as **Annexure-I**. No tank trucks have been allotted in the name of any organization. Presently, 140 tank trucks operated by 140 transporters are running under SOC. Out of these 140 tank trucks, no tank trucks has been stopped from NRL side.

- Undertaking to be obtained from NRECCSL that EMI shall be deducted by NRL from NRECCSL's monthly medicine bill and in case of any default, NRL shall have the right to take over the medicine stock for recovering the balance outstanding dues, if any.

Reply: Details of the mode of repayment by NRECCSL to NRL are as follow:

- Loan repayable in 18 equated monthly installments at an interest rate equivalent to NRL's borrowing rate (which is presently 8.55%) plus 2% per annum.
- Amount recovered by NRL till 31st January 2014 is Rs 6,80,902.00 (Rupees six lakhs eighty thousand nine hundred and two only).
