This has reference to your application no- nil dated 01-04-2021 seeking information under RTI Act 2005. Please find below the reply to the queries raised by you:

Q.N.1 From 01/04/2020 to 28/02/2021, how much of Petrol and Diesel, NRL exported to Bangladesh?

Reply : Export figs of Petrol and Diesel to Bangladesh between 01.04.2021 to 28.02.2021 are as given below-

- a) Petrol :- NIL
- b) Diesel :- 45.4 TMT.

Q.N.2 In the above period, how much loss NRL made for exporting to Bangladesh, assuming those quantity were sold in India?

Reply : The export of petroleum products from India to Bangladesh is in line with the 'Neighbourhood First policy, of Government of India to boost bilateral trade between the two countries and sub-regional cooperation.

NRL exporting HSD to Bangladesh is primarily aimed at seeding the "natural" export market with a long term view. Ready market of HSD in neighboring Bangladesh will help NRL in exporting larger quantity of HSD through pipeline thereby mitigating losses in transporting product to far distance location in domestic market.

NRL, a Govt of India Enterprise, is exporting Diesel to Bangladesh based on above perspective. Calculation of loss or gain in short term is not practical.

Q.N.3 How much loss NRL made in terms of excise benefit for exporting to Bangladesh?

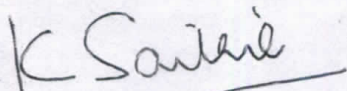

- Q.N.3** In absence of 1 and 2, copy of any proposal or note initiated on the matter by the MOPNG.
- Q.N.4** OM No. C-36011/22/2012-Vig. dated 19.11.2013 issued by MOPNG states that In case a JV or subsidiary is registered in a foreign country, the vigilance set up would be constituted in a manner that is not in any way contradictory to the Act/provisions under which the Company is registered or the laws of the host country and as decided by the board of the JV or subsidiary. But, it is not made clear in this OM dated 19.11.2013 that whether the employees of Indian CPSEs deputed or seconded to various positions in the foreign JVs and subsidiaries will also be governed by the policy and procedures decided by the Board of the foreign JV and subsidiary or not. Please provide copies of orders or communication or any document of MOPNG or any other Ministry or Department or Agency showing clarity on the matter.
