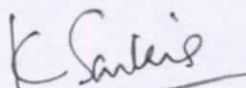

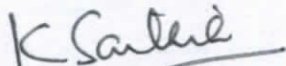

This has reference to your application no. nil dated 21-10-2019 seeking information under RTI Act 2005. Please find below the reply to the queries raised by you:

Q.N.1 You are aware that as per the guideline dated 07.05.2012 issued by the Ministry of Petroleum and Natural Gas (MoPNG), import price of RPC should be used as floor price in the bidding process, in view of this please let me inform regarding the methodology followed by your good organization while fixing the reserve price of RPC.

Reply: Circular dated 07.05.2012 states that import parity price with freight charges, quality differentials, marketing cost and margin and other necessary adjustment should be used as the floor price in the bidding process. The notification itself stipulates that various other factors are to be taken into consideration while fixing the floor price and not only the import parity price.

NRL produces RPC of Grade A quality which is similar with the RPC produced by Guwahati refinery of IOCL. NRL's pricing policy is line with import parity price principle and also keeping in view the prices fixed by Indian Oil Corporation Ltd (IOCL), a public sector undertaking, who is the market leader. Reserve price for RPC is declared after obtaining approval from Management.

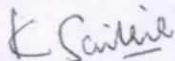
