Sir, have Numaligarh Refinery Ltd. (NRL) Golaghat District, Assam informed you or the other competent authority like OISD, DGMS for above incident? If yes, please issue to me the copies of all letters and communication.

Q.N.2 Sir, have MoPNG or other competent authority made any enquiry against the incident? If yes, please issue all the enquiry reports.

Reply Q.N.1 to 2:

Q.N.3 Sir, what are electrical circuit breakers or trip mechanism as per MoPNG guidelines used in Oil Refineries and their installations in our country? What are the circuit breakers used in NRL Township of NRLtd? Why that circuit breaker in NRL Township did not work when the elephant was electrocuted? Or there was no such type of safety device on that electric line?

Reply:

- As Numaligarh Refinery Township falls under residential area hence, MoPNG guidelines are not applicable.
- Circuit Breakers used in NRL Township - Air Circuit Breakers, SF6 Circuit Breakers
- As per information received from concerned electrical personnel at site, a Switch Fuse Unit (SFU) was present to isolate any electrical circuit. However, the SFU and other electrical components were taken by the concerned Govt. Officials for further investigation. Thus, the working of the SFU could not be ascertained.
- As mentioned above, protective Switch Fuse Unit (SFU) was said to be present at site as safety device.

Q.N.4 Sir, NRLtd and NRL Township fall within 22.8 KM from the boundary of Kaziranga National Park and Tiger Reserve (KNP & TR) and NRL Township falls within No Development Zone (NDZ) of NRLtd. Which extends to the Eastern Boundary of KNP & TR Have NRLtd authority issued any SOP or Order or Circular to their Officials on how to deal with any wild animal and how to make necessary precaution to their people and the wild animal in particular. Please issue to me all such SOP, Order and Circulars.

Reply: The availability of any such documents (viz. SOP, Order, and Circulars) is not known to us.

Q.N.5 Sir, present NRL site was earlier wild animal especially elephant infested area. Have MoPNG or NRL or any competent authority done any survey before inception of NRL in 1991 and prepared any EIA like report? If yes please issue to me copies such report

As per the Interview Result of the Advertisement No.04/2023 SPECIAL RECRUITMENT DRIVE FOR PwBD, the post of GET Computer Science has been left vacant as no suitable candidate was found for the eligible subcategories which NRL follows (a) D, HH(b) OA, OL, CP, LC, Dw, AAV (c) SLD, MI (d) MD involving (a) to (d) above. I wanted to know whether NRL will recruit again for the vacant post in the future and will it modify its eligibility criteria of PwBD to fill the backlog post in the next recruitment.

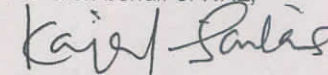

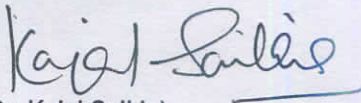

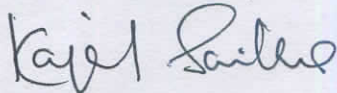
