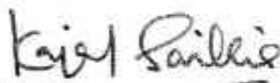

9. Root cause of the Incident:

Based on the observations / examination of the accident site, damaged components, log book records, DCS trends and interview with concerned personnel / employees on 31.05.2023 & 01.06.2023, the Committee has arrived at the following probable cause analysis:

➤ Valve Failure:

- i. Sample globe valve from warehouse was taken to workshop. After machining and PMI, it was identified that SS 410 was used in bevelled portion in one side. The failed valves break away portion was also checked and found P5 metallurgy near the fracture. Hence it is inferred that the newly installed valves had manufacturing defects.
- ii. Brittle fracture might have happened due to hydrogen embrittlement at the bevel end of the "Y" type globe valve which resulted in release of hydrogen, hydrogen sulphide and hydrocarbon followed by explosion and fire.

➤ Source of Leak:

- i. Leak from the sheared off area of 2" Y type globe valve from the HT & LT tapping of LT- 8304 stand pipe of 04-VV-04 (Cold high pressure separator).

➤ Source of Ignition:

- i. The shearing off portion of the stand pipe might have contacted with the metal/ pipe line which could have resulted in spark generation leading to ignition/ fire of the hydrogen/ hydrocarbon vapour.
- ii. Fire might have occurred due to accumulation of electrostatic charges at 2" pipeline when the hydrogen was exposed to atmosphere at very high pressure or due to spark from electrical junction box (Gap in the electrical junction box) existing in the vicinity.

10. Recommendation:

- i. Suitable action may be initiated for failure of the valves and suitable mechanism should be adopted to ensure detection of such defects. Some of the possible suggestions are as under:
 - a. Proper scrutiny of TPI witness test certificates during material receipt.

- viii. NRL shall identify the reasons for unit upsets on 29.05.2023 (6 times of fractionator bottom pump tripping, off gas compressor and RGC trip) and to take remedial measures to prevent recurrence.
- ix. The refinery must ensure that all electrical equipment / fittings fitted in the plant area are meeting the hazardous area classification and all such fittings should be maintained properly.
- x. All the cable glands, Junction boxes shall be inspected for tightness as per OISD-RP-147 and records shall be maintained.
- xi. NRL shall conduct a comprehensive fire proofing study as per clause 5.3 of OISD-STD-164, gaps & deviations if any shall be addressed accordingly.
- xii. NRL shall conduct a comprehensive study to ascertain the availability of firefighting equipment's at the leak prone areas.
- xiii. NRL shall conduct a dispersion analysis at HCU as per clause "5.17 Detection System and Alarm" of PNGRB (T4S for Petroleum Refinery and Gas Processing Plants) Regulations 2023 and accordingly gas detectors shall be provided.
- xiv. Continuity jumpers shall be provided for hydrogen, LPG, pipelines, equipment's etc to ensure the resistivity is within the stipulated limit.
- xv. NRL shall ensure that the DCS engineer acknowledges all the activities mentioned in the start-up procedure in order to ensure that all the activities are completed as per the procedure.
- xvi. Siren code mentioned in the ERDMP plan should be followed. All clear siren should be given after the completion of emergency handling.
- xvii. Records should be maintained upon head counting exercise undertaken across the refinery upon completion of Level-2 emergency handling.
- xviii. Level-2 emergency handling should be practiced through regular mock drills to improve the response mechanism.
- xix. The Mutual aid partners should be requested to mobilize their resources immediately upon declaration of Level-2 emergency.
- xx. All the interlocks should be kept in line during start-up activities and normal operation. Any deviations should be approved at suitable management level as per the company's policy.
- xxi. The procedure for the procurement of critical, High pressure and H₂ service valves shall be in place. Procurement of such fittings should not be done along with the normal valves. PQC for procurement of such fittings to be clearly defined with service and pressure rating.

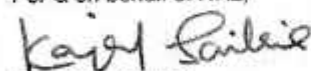
