



Clause 27(a), (b), (c) on "Absence from duty" of Conduct Discipline and Appeal Rules of Numaligarh Reply: Refinery Limited, details about "Absence from Duty" which is reproduced below-

(a) No Management Staff shall absent himself from duty or be late in attending office or leave the station without having first obtained the permission of the Competent Authority.

Provided that, in the case of unavoidable circumstances where availing of prior permission is not possible or is difficult, such permission may be obtained later subject to the satisfaction of the Competent Authority that such a permission could have not been obtained.

(b) No Management Staff shall ordinarily absent himself in case of sickness or accident without submitting a proper medical certificate.

Provided that, in the case of temporary indisposition or sickness of a casual nature, the production of a

medical certificate may be dispensed with.

(c) If a Management Staff overstay beyond the period of leave originally granted or subsequently extended or is otherwise absent beyond 21 days continuously without prior permission of or intimation to the Competent Authority, empowered to grant him leave, he shall be treated to have voluntarily abandoned the company's services and the Competent Authority may pass orders accordingly, without the necessity of disciplinary proceedings under the CDA rules of the Company. A communication relating to such order having been passed by the Competent Authority shall be sent to the staff concerned at the last known address on record.

In case, you are not satisfied with the above reply, you may make an appeal to the First Appellate Authority within 30 days from the date of receipt of this letter as per provision at Section 19 of the RTI Act, 2005, whose details are as under.
