**EXECUTIVE SUMMARY** 

Since its establishment in 1993 following the Assam Accord of 1985, Numaligarh Refinery

Limited (NRL) has played a pivotal role in socio-economic development, especially in Assam

and the North East. Officially inaugurated in 1999 by former Prime Minister Shri Atal Bihari

Vajpayee, NRL has consistently committed to sustainable practices and corporate social

responsibility (CSR). NRL is dedicated to achieving net-zero emissions by 2040, in alignment

with India's National Sustainability Goals. A cornerstone of NRL's commitment is its

comprehensive CSR and Sustainability Policy, which allocates 2% of the company's average

profit-before-tax to a wide range of community development projects. These projects are

strategically categorized into 12 thematic areas, ensuring a holistic approach to community

welfare.

To assess the effectiveness, impact and sustainability of its initiatives, the Indian Institute of

Corporate Affairs (IICA) has conducted a thorough Social Impact Evaluation. This extensive

assessment covered 51 projects across the 12 thematic areas, utilizing diverse methodologies

to provide a detailed understanding of the societal benefits and outcomes of NRL's efforts.

The Social Impact Evaluation of Numaligarh Refinery Limited's (NRL) projects employed a

robust and multi-faceted methodology to ensure a comprehensive assessment of the initiatives'

effectiveness and societal impact. This detailed approach integrated various established

frameworks and processes, providing a thorough understanding of the outcomes and guiding

future interventions. Key methodologies and steps involved in the evaluation process include:

**Logical Framework Analysis (LFA)** 

Purpose: LFA offers a structured approach to project planning, implementation, and

evaluation.

**Objectives:** Clearly defined project goals and objectives.

Outputs: Specific deliverables or products resulting from the project activities.

**Outcomes**: The broader changes or benefits resulting from achieving the outputs.

Assumptions and Risks: Identification of underlying assumptions and potential risks that

could affect project success.

**Utility:** LFA helps in systematically organizing project elements and ensuring alignment

**Indicators**: Quantitative or qualitative metrics used to track progress.

Utility: This methodology facilitates tracking progress, identifying gaps, and making

necessary adjustments to enhance project effectiveness.

**In-depth Interviews**: Detailed interviews with project beneficiaries and stakeholders.

**Focus Group Discussions (FGD):** Group discussions to gather diverse perspectives and insights.

**Key Informant Interviews (KII):** Interviews with individuals having extensive knowledge and involvement in the projects.

#### 5. Data Analysis and Interpretation

Collected data underwent meticulous analysis and interpretation, leading to the synthesis of findings into a comprehensive report. This phase involved:

Quantitative Analysis: Statistical analysis of numerical data.

Qualitative Analysis: Thematic analysis of qualitative data

#### 6. Report Synthesis and Recommendations

Findings were compiled into a detailed report, including actionable recommendations for future interventions. This report aimed to provide practical insights for enhancing the effectiveness and impact of NRL's initiatives.

#### **Monitoring and Verification Mechanisms**

To ensure data accuracy and consistency, robust monitoring and verification mechanisms were implemented, including:

**Geo-tagging**: Using geographic tags to verify the locations of data collection points.

**Real-time Data Uploads:** Immediate uploading of data to a central database for ongoing monitoring.

**Daily Backups:** Regular backups of collected data to prevent loss.

**Phone Verification:** Randomly selected samples were verified through follow-up phone calls to confirm the authenticity of the data.

This comprehensive methodology ensured a thorough and reliable assessment of NRL's projects, providing valuable insights into their societal impact and guiding future CSR efforts.

The Social Impact Evaluation by the Indian Institute of Corporate Affairs (IICA) on Numaligarh Refinery Limited's (NRL) CSR initiatives highlights significant advancements in Assam's livelihood enhancement, environmental sustainability, and community empowerment. The rubber plantation project has generated immediate employment and is set to provide

economic benefits with latex harvesting starting in January 2024, while also aiding soil conservation and biodiversity.

Custom Hiring Centers (CHCs) have doubled crop production, reduced labor costs, and improved agricultural productivity, promoting sustainable farming aligned with several UN Sustainable Development Goals (SDGs). The distribution of fruit-bearing saplings has positively impacted 68.75% of beneficiaries, enhancing nutrition and dietary diversity despite soil quality challenges. NRL's initiatives showcase strategic investments in long-term economic empowerment, environmental health, and sustainable community development.

Findings in the thematic area of Education reveal substantial enhancements in infrastructure and student engagement. Classroom construction and renovation improved the learning environment, with 75% of respondents reporting increased attendance. Additionally, 99.2% noted better comfort and study efficiency due to new desk benches. The scholarship program alleviated financial burdens, enabling students to pursue higher education and boosting their academic and career aspirations. These initiatives align with SDGs, promoting quality education (SDG 4), reducing poverty (SDG 1), and fostering sustainable communities (SDG 11), ultimately empowering students and contributing to long-term socio-economic development.

NRL's healthcare CSR initiatives have significantly improved healthcare access and outcomes in underserved areas. The Mobile Medical Units achieved a 98.13% consultation rate, with 89.32% of beneficiaries finding medical care highly accessible. Nearly half of the beneficiaries (46.26%) reported monthly consultations. The VKNRL School of Nursing has successfully placed around 90 students in healthcare careers, highlighting its impact on addressing the human resource crisis in healthcare. The Anganwadi program has enhanced access to healthcare and nutrition for children, contributing to improved health and early disease detection. These initiatives align with SDGs, promoting good health (SDG 3), quality education (SDG 4), and sustainable communities (SDG 11), effectively addressing key healthcare challenges and advancing public health in India.

The NRL Football Academy is a pivotal initiative fostering socio-economic development and athletic excellence in a geographically deprived region, with 98% positive feedback from 26 players regarding cleanliness and coaching quality. The academy's inclusive approach, drawing talent through familial connections, peer influence, and direct outreach, democratizes access to quality sports education. It provides free coaching, three jerseys per year, and holistic support including scholarships and meals. Despite geographical isolation limiting competitive exposure, the academy's 3-star AIFF accreditation, professional oversight by Bhaichung Bhutia Football Schools, and robust monitoring mechanisms ensure high standards. Particularly for female players, who expressed overall

satisfaction and diverse career aspirations, the academy promotes gender equality and aligns with SDGs. Addressing resource and exposure challenges will enhance its impact, making it a model for leveraging sports for broader social objectives.

The Social Impact Evaluation study by the Indian Institute of Corporate Affairs (IICA) reveals that the Swanirbha project has significantly improved the lives of beneficiaries, providing a beacon of hope and empowerment for unemployed youth and enhancing livelihoods in their community. Through diverse employment opportunities, such as transitioning from tea cultivation to more profitable ventures like pig farming and broiler farming, beneficiaries have experienced tangible economic growth. Collaborative efforts in broiler farming and catering units have bolstered economic stability, fostering a sense of community and shared success. Despite challenges in ventures like battery rickshaw and goat rearing, the project has steadfastly driven economic empowerment. Testimonials highlight gratitude for NRL's support, enabling financial self-reliance and business expansion. Amidst India's persistent multidimensional poverty, exacerbated by the COVID-19 pandemic, the Swanirbha project stands out as a transformative initiative, significantly improving the financial situations of its beneficiaries and fostering sustainable livelihoods.

The impact evaluation study conducted by IICA has revealed significant challenges in the field of skill development at Golaghat ITI College. The study identified critical infrastructure deficiencies, including the absence of a hostel, playground, and bike/cycle stand, impacting students' convenience, safety, and well-being. Moreover, the lack of direct placement opportunities poses hurdles to students' career prospects post-graduation, emphasizing the need for a structured placement and career guidance system. Anticipated growth necessitates additional staff to maintain educational standards and student satisfaction. Addressing these

challenges is crucial for enhancing the institution's functionality and ensuring the holistic growth of its students.

NRL's establishment of Anganwadi Centers has significantly improved the nutritional status and health of children in served communities, enhancing access to healthcare and facilitating early disease detection. The centers not only provide healthcare but also offer education, sports, and nutrition facilities, contributing to overall community well-being. NRL's broader initiatives, including mobile medical camps, Niramoy, VK NRL School of Nursing, and Anganwadi renovation programs, align closely with Sustainable Development Goals (SDGs) related to healthcare and sustainable development. Mobile medical camps and Niramoy support SDG 3 by providing essential healthcare services and improving emergency medical care. The VK NRL School of Nursing addresses SDG 4 by training healthcare professionals, while the Anganwadi renovation program supports SDGs 2 and 3 by enhancing access to nutrition and healthcare services for women and children. These initiatives play a pivotal role in advancing global health and well-being agendas.

The findings reveal significant infrastructure improvements in the aspirational district Darrang, supported by NRL's funding of 7 crore rupees between 2019 and 2021. Enhancements include improved healthcare facilities, school infrastructure development, and progress in toilet construction initiatives. Challenges remain, such as incomplete electrification and delayed Anganwadi centre construction due to funding constraints. However, these efforts align with multiple Sustainable Development Goals, indicating progress towards holistic community development in the region.

#### INTRODUCTION

#### About Numaligarh Refinery Limited

Established on April 22, 1993, in accordance with the Assam Accord of 1985, Numaligarh Refinery Limited (NRL) stands as a Category-I Miniratna Central Public Sector Enterprise (CPSE) under the Ministry of Petroleum and Natural Gas, Government of India. Significantly, NRL's status was elevated from Schedule B to Schedule A CPSE on July 4, 2023. Dedicated to the nation by former Prime Minister Shri Atal Bihari Vajpayee on July 9, 1999, NRL's 3 Million Metric Tonnes Per Annum (MMTPA) Refinery has showcased commendable performance since commencing commercial production in October 2000. Not only has NRL played a crucial role in the socio-economic development of Assam and North East India, but its impact is also felt globally through the export of products, notably Paraffin Wax.

In alignment with the Government of India's target of achieving net-zero emissions by 2070, NRL has set an ambitious roadmap to reach its net-zero goals by 2040. As part of this commitment and in line with the National Green Hydrogen Mission, NRL has initiated the establishment of a Green Hydrogen plant with a capacity of 300 kg/hr (18 MW) within the Refinery premises.<sup>1</sup>

NRL has outlined its 'CSR and Sustainability Policy,' emphasizing a vision to pursue activities that contribute to inclusive community development. The mission involves identifying and implementing welfare schemes based on genuine needs through comprehensive assessments and collaboration with local stakeholders. The policy adheres to statutory requirements, aligning with Section 135 of the Companies Act 2013 and relevant CSR guidelines.

NRL categorizes its CSR activities under 12 broad heads and they are as follows:

- 1. Livelihood Generation
- 2. Education
- 3. Skill Development
- 4. Sanitation
- 5. Health Care
- 6. Arts

The execution of major projects follows a transparent, project-based approach, and the annual budget is allocated based on 2% of the average profit-before-tax of the preceding three years. CSR initiatives are structured through a two-tier organizational framework, ensuring effective communication, monitoring, and periodic evaluation. The policy highlights a local focus within a 10 km radius of NRL's operations, limiting administrative overheads to 5% of the annual CSR budget. <sup>2</sup>

#### About the projects under Evaluation

In the extensive Social Impact Evaluation conducted by IICA for NRL, the assessment covers 12 overarching themes, comprising a total of 51 individual projects. This thorough examination explores the diverse dimensions of NRL's initiatives, providing a detailed and insightful analysis of their societal implications. The evaluation employs methodologies such as Logical Framework Analysis<sup>3</sup>, Result Framework Document<sup>4</sup>, and SDG Framework to ensure a comprehensive understanding of the impact of NRL's interventions.

IICA employs the SDG framework to gauge the congruence of Social Impact Evaluation findings with the Sustainable Development Goals (SDGs). In September 2015, the United Nations called upon global businesses, non-profits, individuals, and government agencies to collaborate on addressing society's major challenges by 2030. The 2030 agenda for sustainable development encompasses 17 SDGs, each with 169 ambitious targets. The SDGs framework serves to assess whether an organization's programs, projects, or activities align with and contribute to the achievement of these SDGs. It evaluates if the social impact generated by the organization's CSR activities contributes toward the realization of these 17 SDGs. This alignment in Social Impact Evaluation study enables companies to demonstrate their significant

contributions to the realization of Sustainable Development Goals, showcasing their commitment to global sustainability.<sup>5</sup>

The Logical Framework Analysis (LFA), also known as a Project Framework, serves as a structured planning and management tool for development projects. This model, originating in the United States and later embraced by various donors, including the Department for International Development (DFID), is presented in a tabular format to provide a clear, concise, and systematic overview of key project components. The log frame succinctly outlines the project's intended achievements, details the activities to reach its outputs and purpose, identifies necessary resources, anticipates potential challenges, and articulates the criteria for measuring and verifying progress and overall success. In essence, the LFA acts as a comprehensive guide for project planning and evaluation, fostering a logical and organized approach to development initiatives.

Government institutions play a crucial role in delivering essential services vital for national well-being and development. To optimize the efficiency and economy of public service delivery, these institutions are mandated to formulate strategic plans, allocate resources accordingly, and diligently monitor and report results. The success of various government projects, programs, and initiatives hinges on clear articulation of expected results, ensuring measurable objectives, progress monitoring, and facilitating adjustments for effective implementation. A **results framework** (**RF**) serves as a pivotal tool in aligning government efforts with strategic development objectives, linking interventions to intermediate outcomes and measurable results within defined time frames, typically a financial year. The RF not only shifts the government's focus from process to results but also provides an objective basis for fair program performance evaluations at the end of the stipulated period. Implementing an RF system demands both organizational and cultural changes within government entities, recognizing varying levels of readiness, maturity, and capacity across different departments. For optimal effectiveness, the RF should transcend being merely a technical instrument, incorporating well-designed elements, standardizing mandates, integrating good governance principles, and addressing institutional capacity while responding to the demand for evaluation.

#### RESEARCH METHODOLOGY

IICA's Six-Step Approach for Research

Research Methodology outlines a series of steps involved in conducting a research with a purpose. The procedure and the techniques used in identifying, collecting and analysing information or data regarding a specific topic is defined through a research methodology. The present study uses quantitative as well as qualitative methods and both the primary and secondary data to assess the needs of the target area. Primary data was collected by conducting extensive fieldwork in all the 51 projects covering 12 broad themes of NRL.

IICA has employed a comprehensive six-step approach. Beginning with an extensive literature review, the study progressed to the preparation, pre-testing, and finalization of research tools for data collection. A dedicated survey team was formed and trained for effective fieldwork across all project areas. The fourth step involved the collection of primary data through indepth interviews with beneficiaries, supplemented by Focus Group Discussions (FGD) and Key Informant Interviews(KII). Subsequently, the fifth step encompassed the meticulous analysis and interpretation of the collected data. The sixth and final step involved synthesizing these findings into a comprehensive report, along with recommendations. This meticulous process is designed to ensure the credibility, accuracy, and thoroughness of the impact assessment, reflecting IICA's commitment to evidence-based decision-making and the successful execution of projects.

The implementation of robust monitoring and verification mechanisms is integral to the success of the evaluation conducted. To achieve this, all projects and areas have undergone a meticulous process, including geo-tagging and capturing photographs of each interviewed

beneficiary. Real-time data has been consistently uploaded to the cloud, subject to verification by the relevant authority through a designated app (Kobo Toolbox). Daily backups are diligently maintained, complemented by weekly reviews conducted by the project team to ensure data accuracy and consistency. In addition, a subset of randomly selected samples is contacted for phone verification, adding an extra layer of validation. Field-level monitoring officers were deployed to oversee enumerators, ensuring strict adherence to mapped targets and scheduled visits.

#### Sources of Data Collection

This assessment has majorly relied on the primary sources of data. Primary data included the interactions with direct beneficiaries.

#### Methods and Tools of Data Collection

The impact assessment evaluation employed a thorough methodology that seamlessly integrates both quantitative and qualitative methods. With a primary emphasis on assessing the impact of NRL's projects, the evaluation encompassed a total of 51 projects. Conducted by the Indian Institute of Corporate Affairs (IICA), the Impact Assessment adheres to a comprehensive framework known as the Sustainable Development Goals (SDGs) framework.


#### Sustainable Development Framework

The Sustainable Development Goals (SDGs), also known as the Global Goals, represent a transformative agenda adopted by the United Nations in 2015, serving as a universal call to action to address global challenges. Encompassing 17 goals, the SDGs aim to eradicate poverty, safeguard the planet, and ensure universal peace and prosperity by 2030. A distinctive feature of the SDGs is their integration, acknowledging that actions in one domain have interconnected effects across others. The SDGs emphasize a balanced approach, recognizing the interdependence of social, economic, and environmental sustainability.

The commitment of nations extends to prioritizing progress for those furthest behind, seeking to eliminate poverty, hunger, AIDS, and gender-based discrimination. The SDGs underscore the need for collective efforts, leveraging creativity, knowledge, technology, and financial resources from all sectors of society to achieve meaningful outcomes in every context. In addition to the SDGs, the Sustainable Development Framework provides a structured approach to implementing sustainability initiatives. This framework aligns with the SDGs, offering a systematic methodology for organizations and entities to integrate sustainable practices into

their operations, promoting long-term social, economic, and environmental benefits. By adhering to the Sustainable Development Framework alongside the SDGs, entities can contribute effectively to the global agenda for positive and lasting change.<sup>6</sup>

#### SDGs used for Social Impact Evaluation by IICA

India is actively addressing climate change and promoting sustainable development through its commitment to the 17 Sustainable Development Goals (SDGs). Key initiatives include reducing emissions intensity, increasing non-fossil fuel capacity, and creating carbon sinks. By April 2023, India was on track to meet 14 of the 33 SDGs, with notable progress in healthcare, sanitation, and electricity access. The Economic Survey 2022-23 revealed that 41 crore Indians escaped poverty between 2005-06 and 2019-21, demonstrating progress toward the SDG of halving poverty by 2030. Recent legislation, such as the Energy Conservation (Amendment) Bill, promotes renewable energy and carbon credit trading. India aims to achieve 65% non-fossil fuel capacity by 2030, surpassing the 40% target achieved in 2021. The Green Hydrogen

Mission targets 25 million tonnes of green hydrogen capacity, positioning India as a leader in sustainable energy solutions.

Various government initiatives, including Swachh Bharat Mission and Namami Gange Programme, contribute to environmental protection. The Sustainable Development Goals National Indicator Framework 2023 facilitates monitoring and measuring progress, emphasizing India's commitment to global sustainability. In the Climate Change Performance Index 2023, India ranked 8th globally, showcasing significant strides.<sup>8</sup>

The report specifically employs SDGs 3, 6, 4, 8, 5, 13, 7, 11, 12, 14, and 15 to address healthcare, clean water, education, economic growth, gender equality, clean energy, sustainable cities, responsible consumption, life below water, and life on land. Additionally, initiatives like sports, art & culture, and the rehabilitation of PWDs align with SDGs 3, 4, 5, 11, and 10. The efforts in aspirational district Darrang are focused on SDGs 1, 2, 3, and 4, emphasizing no poverty, zero hunger, good health, and quality education.

Though financial benefits are yet to be realized, the project has already become a source of employment for many.

During the social impact evaluation study conducted for NRL by IICA, the farmers revealed the profound impact of NRL's rubber plantation initiative. While economic gains are anticipated in the near future with the imminent harvesting of rubber latex in January 2024, the immediate benefits include the creation of a healthy environment and employment opportunities. In this ongoing tale, NRL's rubber plantation initiative stands as a testament to responsible corporate citizenship. As the rubber trees mature, the landscape transforms, symbolizing a harmonious coexistence between industry, agriculture, and nature. The story continues to evolve, promising a sustainable and green future for the communities of Assam.




Figure 1: Impact of Rubber Plantation on the lives of the beneficiaries




Figure 2: Result of the latex harvest

The Social Impact Evaluation study conducted by IICA reveals a compelling insights, all farmers who were engaged in the rubber plantation initiative facilitated by Numaligarh Refinery Limited (NRL) are yet to harvest latex from their rubber trees.

In terms of environmental stability, sustainable agriculture reports consistently highlight the necessary time for crops like rubber to reach maturity and become productive. This mirrors the current scenario in NRL-supported rubber plantations, where delayed latex harvesting signifies a crucial growth phase, allowing trees to mature and establish robust root systems, thereby significantly contributing to local ecosystem stability. This extended cultivation period plays a vital role in soil conservation, carbon sequestration, and overall biodiversity enhancement, aligning with national and global initiatives promoting sustainable farming to combat climate change and preserve environmental health.

From an economic empowerment perspective, the absence of latex harvesting at this stage should not be solely perceived as a delay in financial gains. Instead, it reflects a strategic investment in the long-term economic empowerment of the community. Sustainable agriculture initiatives stress the importance of patience, acknowledging that initial phases often involve substantial upfront expenses and deferred returns.

The economic impact is anticipated to unfold as the rubber trees mature, and latex harvesting commences. This resonates with the overarching objective of NRL's CSR initiative – to establish sustainable income sources for local communities, breaking the cycle of dependency on traditional crops and diversifying income streams. The ultimate aim extends beyond mere financial gain, focusing on the creation of resilient and self-sustaining livelihoods.




#### Impact on livelihood enhancement due to Rubber Plantation

The Impact assessment study conducted by IICA, indicates that despite considerable time and effort invested in rubber planting, individuals involved have yet to realize any significant financial benefits. While employment opportunities have been created, immediate economic progress remains elusive due to the lack of rubber latex harvesting and tree sales. However, there is optimism about future profitability once latex harvesting commences, with some

individuals anticipating substantial profits. The activity is also recognized for its positive environmental impact, suggesting non-monetary benefits. Economic stability appears to hinge on the successful harvesting and sale of rubber latex, emphasizing the dependency of livelihoods on the outcomes of this endeavor.

### Impact on Environment due to Rubber Plantation





When questioned about the environmental impact of rubber plantation by IICA, all beneficiaries unanimously express an overall positive perception, indicating a widespread acknowledgment of its beneficial effects on the environment.

# Sustainability of Rubber Plantation

The impact assessment findings reveal a mixed perspective on the sustainability of the rubber plantation. While some respondents express intentions to ensure long-term sustainability through measures like regular maintenance and disease prevention, others highlight concerns about the lack of comprehensive planning and provision of necessary medicines for tree health. Despite acknowledging the importance of consulting agricultural experts and planting more rubber seedlings, there is a notable absence of concrete long-term plans to address sustainability challenges. Moreover, the reliance on profits from rubber latex sales to fund

future planting activities raises questions about the financial sustainability of the plantation. These findings highlights the need for more robust sustainability strategies, including proactive disease prevention measures and effective resource allocation, to ensure the continued viability of the rubber plantation in the long term.

The findings also highlights crucial areas of concern and opportunity aligned with Sustainable Development Goals (SDGs) 8, 9, 12, and 15. SDG 8, Decent Work and Economic Growth, highlights the economic significance of the plantation, yet the reliance solely on profits from rubber latex sales for future planting activities raises questions about the sustainability of livelihoods and employment. Meanwhile, SDG 9, Industry, Innovation, and Infrastructure, emphasizes the need for innovative solutions to address challenges such as disease prevention and resource allocation within the plantation. However, the absence of concrete long-term plans indicates a potential gap in leveraging innovation to foster sustainable growth. SDG 12, Responsible Consumption and Production, calls for sustainable agricultural practices, but concerns about the lack of comprehensive planning and provision of necessary medicines highlight the need to enhance resource efficiency and minimize waste within the value chain. Finally, SDG 15, Life on Land, emphasizes the importance of sustainable land management and biodiversity conservation, suggesting opportunities to implement sustainable planting and tapping practices that preserve ecosystems while ensuring the plantation's long-term viability. Overall, addressing these sustainability challenges through proactive measures aligned with the

SDGs is essential to fostering resilient, inclusive, and sustainable development within the rubber plantation context.

#### **Effectiveness of Rubber Plantation**

NRL's rubber plantation initiative in Assam showcases effectiveness through its commitment to the protection of environment, social empowerment, and economic sustainability. The initiative promotes soil conservation and biodiversity enhancement, aligning with global efforts to combat climate change. The generation of employment opportunities demonstrates immediate social impact, while the anticipation of future financial gains signifies a strategic investment in long-term economic empowerment for local communities. Despite the initial absence of significant profits, NRL's initiative lays the foundation for resilient livelihoods and a sustainable future, exemplifying responsible corporate citizenship and promising enduring benefits for the region.

Figure 4: Value Chain mechanism for Rubber Plantation





However, amidst these challenges, the SwaNirbha project of NRL has emerged as a beacon of hope for many beneficiaries. The testimonials provided by beneficiaries of the Swanirbha project to IICA, highlight its significant impact on improving their financial situations and fostering economic empowerment. Respondents express gratitude for the employment opportunities provided by NRL, which has enabled them to become financially self-reliant and even expand their businesses independently. For instance, individuals who were previously involved in tea cultivation have found greater profitability in ventures like pig farming and broiler farming, contributing to their economic well-being. The expansion of initiatives like sewing centers has not only increased income but has also fostered savings and economic stability for participants. However, some participants have not yet seen significant changes in their daily lives, such as those involved in the clothing shop venture or those affected by setbacks like losses from goat rearing projects. Overall, the Swanirbha project has brought about tangible improvements in the lives of its beneficiaries, enhancing their economic well-being and quality of life.

Many respondents express a marked increase in enthusiasm and newfound knowledge gained through their involvement in various aspects of the project, such as broiler farming, pig farming, and catering. The project has not only equipped them with practical skills related to their respective ventures but has also provided insights into market systems and business operations, enhancing their overall proficiency. Furthermore, beneficiaries have taken initiative in skill development within their communities, sharing their expertise and experiences to train others and contribute to collective growth.

Despite encountering setbacks, such as the failure of ventures like battery rickshaw and goat rearing, beneficiaries acknowledge the overall positive impact of the project in empowering them economically. Additionally, testimonials indicate that the project has not only strengthened beneficiaries' financial positions but has also contributed to their mental and emotional well-being. Overall, the Swanirbha project emerges as a vital catalyst for

socioeconomic upliftment, providing tangible benefits to participants and fostering a sense of empowerment within the community.

#### Recommendations by Beneficiaries

The testimonials provided by project beneficiaries underscore the potential of the project to empower individuals financially and foster self-reliance within the community. Participants express gratitude for the opportunities provided by the project and advocate for its expansion to benefit more young people like themselves. Requests for increased financial support from NRL highlight the importance of ongoing investment in projects like integrated farming to maximize their impact. Suggestions for project improvement include increasing funding to expand farms and raise more broilers or pigs, as well as offering advice on diversifying income streams, such as by opening multiple catering units or utilizing sewing centers to inspire entrepreneurship within the community. However, some participants express a lack of experience or ideas regarding further project support, while others indicate a need for more discussion and planning within their Self-Help Groups to generate innovative suggestions for project enhancement. Overall, these testimonials reflect a collective desire for continued support and growth opportunities through the project, emphasizing its potential to drive long-term economic empowerment and self-sufficiency among participants.

#### Sustainability of SwaNirbha

The Swanirbha project, spearheaded by NRL, stands as a commendable example of sustainable development in alignment with the United Nations Sustainable Development Goals (UN SDGs). Recommendations for increased financial support and project expansion align with the principles of sustainable development, emphasizing the need for ongoing investment in initiatives that promote economic empowerment, social inclusion, and environmental stewardship.



CHCs have the potential to address the machinery needs of a significant proportion of land holdings, particularly those owned by small and marginal farmers, who constitute the majority of farmers. <sup>10</sup>



Fruit trees sustain themselves through the process of photosynthesis. Their leaves absorb carbon dioxide, and their roots absorb water. Using sunlight as energy, these elements are converted into compounds like glucose, which nourish the tree. Oxygen is a delightful byproduct of this process, released into the atmosphere. Remarkably, one fruit tree can produce enough oxygen for two people in a year!


This absorption of CO2 and release of O2 significantly diminishes pollution, enhances air quality, and lowers temperatures - all of which combat climate change! Research from Lancaster University revealed that roadside fruit trees can reduce nearby indoor pollution by over 50%!

Fruit trees play a crucial role in our protection. Deforestation has been directly linked to the severity of damage caused by floods and cyclones in recent years. Fruit trees are also essential

for maintaining healthy ecosystems and promoting biodiversity. Furthermore, by enhancing the health of soil and groundwater, they create an environment conducive to further growth.<sup>11</sup>

The social impact assessment carried out by IICA presents a comprehensive perspective that differs from scientific views on the planting of fruit-bearing saplings.





The Social Impact Evaluation by IICA highlight various impacts and challenges associated with the initiative to distribute fruit tree saplings by NRL. Based on the responses provided, it can be inferred from the graph above that a majority (68.75%) of the beneficiaries perceive a positive impact on their lives upon receiving fruit-bearing saplings. This indicates that the initiative by NRL to distribute fruit tree saplings has been beneficial for the recipients, contributing positively to their livelihoods or quality of life in some way. However, it's important to address the concerns or challenges mentioned by the remaining 31.25% to ensure the effectiveness and sustainability of the initiative for all beneficiaries.

While 50% of respondents mentioned enhanced nutrition for children and family members as a significant impact, others cited benefits such as increased variety in diet and decreased


# Impact of Mobile Medical Camp (MMC)

The data from the medical mobile care initiative indicates a high level of accessibility to medical consultation among the beneficiaries, with 98.13% reporting that they have received medical consultation. This demonstrates the effectiveness of the program in reaching the target population and providing essential healthcare services. Furthermore, the majority of beneficiaries (89.32%) perceive the accessibility of medical care as either accessible or very accessible, indicating that the program has successfully addressed the issue of access to healthcare services in underserved areas. The frequency of medical consultations also appears to be satisfactory, with nearly half of the beneficiaries (46.26%) reporting monthly consultations. This indicates regular access to healthcare services, which is crucial for maintaining overall health and well-being. However, it is worth noting that a small percentage of beneficiaries (1.87%) reported not receiving medical consultation, suggesting potential areas for improvement in reaching all segments of the target population. Overall, the data reflects a positive impact of the medical mobile care initiative in providing accessible and regular healthcare services to the beneficiaries.

## Sustainability of Mobile Medical Camp



Responses from participants show significant benefits, including the alleviation of joint pain through medication provided at the camps, substantial improvements in health conditions following medical counseling and treatment, and the mitigation of issues such as high blood pressure and gastric problems. Additionally, the camps have facilitated better access to healthcare services, resulting in convenience and enhanced physical health for attendees. Notably, individuals have reported a reduction in disease frequency and improved mobility, with some previously immobilized by back pain now able to walk comfortably. These observations collectively affirm the effectiveness and value of NRL's mobile medical initiatives in fostering healthier communities and addressing healthcare needs at the grassroots level.




Impact of VKNRL School of Nursing

This high placement rate underscores the effectiveness of the school in preparing students for their professional careers. Moreover, the holistic development of students is evident, as they not only excel academically but also socially and in sports. Overall, the impact of the programs provided by the VKNRL School of Nursing is profound, equipping students with the necessary skills, knowledge, and opportunities for a successful career in nursing.



Impact of Anganwadi Program



The establishment of Anganwadi Centers by NRL has had a significant impact on the nutritional status and overall health of children in the communities they serve. By setting up Anganwadi Centers in villages, access to healthcare services has become more convenient, as mentioned by beneficiaries who now find it easier to access medical treatment. The proximity of the Anganwadi Centers to their homes has reduced the time and effort required to seek healthcare, leading to improved healthcare utilization. Additionally, the presence of experts and healthcare professionals at these centers facilitates early detection and prevention of diseases, contributing to better health outcomes for children. Furthermore, the Anganwadi

programs not only focus on healthcare but also provide education, sports, and nutrition facilities, which contribute to the overall well-being and development of children and families in the community. The impact of NRL's Anganwadi program is evident in the improved access to healthcare, early disease detection, and comprehensive support for the well-being of children and families in the served areas.



# **Healthcare & Sustainable Development Goals**

# **Sports**

Familial connections, peer influence, and direct outreach by academy staff all contribute to the diverse intake of talent. This varied introduction process showcases the academy's broad reach and inclusivity, facilitating access for many young players who might otherwise remain unnoticed. A significant motivator for players is the provision of free coaching, which alleviates financial burdens and democratizes access to quality sports education. The players' motivations are deeply rooted in their aspirations to emulate football icons like Messi and Ronaldo, demonstrating the academy's role in nurturing not just athletic skills but also dreams and ambitions.



The overwhelmingly positive feedback from players regarding their experience at the academy highlights the supportive environment fostered by NRL. With 26 players unanimously praising the cleanliness and coaching quality, it is evident that the academy maintains high standards in both physical infrastructure and training methodology. The provision of three NRL jerseys per year instills a sense of pride and belonging among the players, further cementing their loyalty and dedication to the academy. The role of well-qualified coaches, some with extensive experience in coaching youth teams at various levels, is pivotal in the academy's success. These

coaches bring expertise and a track record of developing young talent, ensuring that players receive top-notch guidance.



However, challenges persist, particularly in terms of exposure to competitive opportunities. The geographical isolation of the region limits the players' participation in state, national, and international competitions, which are crucial for their development and visibility. The coach's suggestion to enhance exposure through increased participation in such competitions is a vital recommendation. This would not only improve the players' skills through real-world experience but also provide them with the necessary platform to showcase their talent on larger stages. Moreover, the internal monitoring by NRL, along with surprise inspections, highlights the academy's commitment to maintaining the integrity and effectiveness of its programs. The involvement of the Bhaichung Bhutia Football Schools (BBFS) as the implementing partner adds a layer of professional oversight, ensuring that the academy's operations align with best practices in sports training and development.

The findings from Focus Group Discussions (FGDs) with female players at the NRL Football Academy reveal a positive and empowering environment. Initially, these girls started playing football as a hobby but now enjoy it immensely, with all expressing happiness in their participation. Their career aspirations are diverse, ranging from becoming police officers and commandos to professional footballers. However, at present, their primary joy comes from playing football, and they report facing no challenges in their engagement with the sport.



This positive experience among female players underscores the academy's role in promoting women's empowerment. By providing a supportive and inclusive environment, the NRL Football Academy empowers young girls to pursue their interests and aspirations, breaking traditional gender norms in sports. The academy's efforts contribute significantly to SDG 5 (Gender Equality) by fostering an environment where young women can thrive and pursue their dreams.





The findings from the Key Informant Interviews (KIIs) with the academy's management, including the manager and the Head of Youth Development, provide deeper insights into the operational ethos and challenges faced by the academy. The academy's 3-star accreditation from AIFF and the merit-based selection process highlight its adherence to high standards and fairness. The absence of specific social or economic criteria for selection ensures inclusivity, offering opportunities based on talent and potential. The comprehensive support provided to players, including free training, scholarships, nutritious snacks, and regular meals, reflects a holistic approach to player development that goes beyond just football skills.



Technical challenges, primarily due to the region's geographic constraints, necessitate additional budgetary allocations for the academy. This is crucial to meet the growing demands for advanced technical training and infrastructure. The management's call for a higher budget and more personnel to enhance the academy's functionality is a pragmatic approach to scaling up operations and meeting the evolving needs of the players. Furthermore, the suggestion to replicate the successful model of the NRL football academy in other regions can serve as a blueprint for developing similar initiatives, thereby expanding the impact of such programs.

This shortfall not only hampers their overall well-being but also undermines their academic performance and college experience. Additionally, the absence of direct placement options poses a formidable barrier to students' post-graduation career prospects, necessitating urgent establishment of a robust placement and career guidance system. Anticipating future growth, the institution must address staffing inadequacies to maintain educational standards and ensure student satisfaction. Proactive measures are imperative to overcome these challenges and foster an environment conducive to holistic student development.

Moreover, the impact evaluation study highlights the urgent need for strategic interventions to bolster skill development at Golaghat ITI College. Efforts must be directed towards addressing infrastructure deficiencies, including the provision of essential facilities like a hostel and playground, to enhance student convenience and safety. Simultaneously, establishing direct placement options and a comprehensive career guidance system is crucial to augment students' employability and career prospects post-graduation. Anticipating future growth, the institution must prioritize staffing requirements to ensure adequate support for students and maintain educational standards. By addressing these critical areas, Golaghat ITI College can realize its potential as a hub for skill development, fostering a conducive environment for holistic student growth and success.

# **Skill Development & SDG**

The impact evaluation study conducted by IICA on Golaghat ITI College underscores the pressing need for addressing infrastructure deficiencies and enhancing skill development, aligning with several Sustainable Development Goals (SDGs). Firstly, the absence of essential facilities such as hostels, playgrounds, and bike/cycle stands negatively impacts student convenience and safety, directly relating to SDG 4 (Quality Education). Addressing these deficiencies would create a conducive learning environment, ensuring inclusive and equitable quality education (SDG 4.1). Secondly, the lack of direct placement options hampers students' post-graduation career prospects, highlighting the need to promote decent work and economic growth (SDG 8). Establishing a robust placement and career guidance system would facilitate

access to employment opportunities and promote sustainable livelihoods (SDG 8.5). Additionally, prioritizing staffing requirements to maintain educational standards aligns with SDG 4, ensuring the provision of qualified teachers and support staff to foster a conducive learning environment (SDG 4.7). By addressing these challenges, Golaghat ITI College can contribute to advancing the SDGs by promoting quality education, decent work, and sustainable economic growth.

# Aspirational District Darrang

The findings from the key informant interview with DC Mr. Bakhtar Ali regarding the impact of NRL's funds on the aspirational district Darrang reveal significant improvements in infrastructure across various sectors. The allocation of funds totaling 7 crore rupees between 2019 and 2021 has notably enhanced infrastructure at the Magoldoi Civil Hospital, including improvements in ambulance services, the animal dormitory, Prasute Mangal Kendra, installation of solar panels, and sub-centre development. Additionally, progress has been made in constructing toilets in 104 schools, with 90% deemed effective, and 66 schools are currently undergoing additional building construction. However, electrification efforts in 402 schools remain partially completed, with only 200-250 schools electrified. While 29 Anganwadi centres are being developed, some are still under construction due to a lack of funds, specifically 1 crore 72 lakh rupees withheld by NRL. Despite challenges, improvements in existing toilets have been noted, and the dormitory at Prasuti Mangal Kendra offers nutritious food and free health check-ups for pregnant women in rural areas, enhancing awareness and healthcare access. Analyzing these findings through the lens of the Sustainable Development Goals (SDGs), improvements align with several goals, including SDG 3 (Good Health and Well-being) through enhanced healthcare facilities, SDG 4 (Quality Education) with school infrastructure development, and SDG 6 (Clean Water and Sanitation) through toilet construction initiatives. Efforts also contribute to SDG 7 (Affordable and Clean Energy) with solar panel installations, and SDG 5 (Gender Equality) by promoting maternal health and wellbeing.

## Recommendations

The Social Impact Evaluation conducted by the Indian Institute of Corporate Affairs (IICA) offers valuable insights into Numaligarh Refinery Limited's (NRL) CSR initiatives. To further enhance the effectiveness and sustainability of these efforts, the following recommendations are proposed:

# **Enhancing Monitoring and Evaluation Mechanisms:**

NRL should strengthen its monitoring and evaluation mechanisms to track project progress and impact more effectively. Implementing real-time data tracking systems and conducting regular field visits will provide timely feedback for course corrections.

Prioritize addressing infrastructure deficiencies identified in various thematic areas. Investments in essential facilities like hostels and medical equipment will improve access to services and beneficiary well-being.

Integrate gender-responsive approaches and promote inclusivity across all initiatives. Ensure equal opportunities for women and marginalized groups, and actively engage them in decision-making processes.

To ensure the continued success of CHCs, it is imperative for NRL to focus on enhancing access and outreach, diversifying services, promoting sustainable practices, investing in capacity building, fostering partnerships, implementing robust monitoring and evaluation, and developing sustainable financing models. Through these concerted efforts, CHCs can continue to serve as invaluable catalysts for inclusive and

sustainable agricultural development, empowering farming communities and fostering resilience in the face of evolving challenges.

#### Education

IICA recommend NRL to continue its efforts in enhancing educational infrastructure and providing scholarships for higher education, while also prioritizing ongoing monitoring, feedback incorporation, and expansion of CSR initiatives to address broader educational needs. By sustaining investments in sustainable infrastructure development, expanding scholarship opportunities, and fostering partnerships with stakeholders, NRL can further promote educational excellence, student well-being, and equitable access to quality education. This holistic approach ensures a long-term commitment to fostering transformative educational experiences, empowering students to reach their full potential and contribute positively to society.

## **Conducting Need Assessment Survey**

To establish a strategic Corporate Social Responsibility (CSR) framework that effectively addresses community needs and maximizes impact, IICA recommend conducting a comprehensive needs assessment. This assessment should involve engaging with stakeholders, including local communities, NGOs, government agencies, and employees, to identify key social, environmental, and economic challenges faced by target communities. By understanding the specific needs and priorities of the communities served, NRL can develop tailored CSR initiatives that address root causes, leverage existing resources, and align with organizational values and capabilities. Additionally, ongoing monitoring and evaluation mechanisms should be integrated to track progress, solicit feedback, and adapt strategies as needed, ensuring the sustainability and effectiveness of CSR interventions over time. Through a strategic and needs-based approach, NRL can enhance its positive impact, foster meaningful partnerships, and contribute to holistic community development.

## **Conducting Social Return on Investment**

For NRL's CSR initiatives, IICA recommend conducting a thorough Social Return on Investment (SROI) analysis to accurately assess the social, environmental, and economic value generated by these interventions. By quantifying the social impacts alongside financial investments, NRL can gain deeper insights into the effectiveness and efficiency of its CSR programs, identifying areas of success and areas for improvement. This comprehensive

evaluation will enable NRL to demonstrate the tangible benefits and long-term value created for stakeholders, empowering informed decision-making, resource allocation, and strategic planning. Through SROI analysis, NRL can enhance accountability, transparency, and stakeholder engagement, ultimately maximizing the positive social impact of its CSR initiatives.
