






## **Overview of CSR at NRL**

Since its establishment in 1993 following the Assam Accord of 1985, Numaligarh Refinery Limited (NRL) has played a pivotal role in socio-economic development, especially in Assam and the North East. A cornerstone of NRL's commitment is its comprehensive CSR and Sustainability Policy, which allocates 2% of the company's average profit-before-tax to a wide range of community development projects.


NRL has outlined its 'CSR and Sustainability Policy,' emphasizing a vision to pursue activities that contribute to inclusive community development. The policy adheres to statutory requirements, aligning with Section 135 of the Companies Act 2013 and relevant CSR guidelines. NRL categorizes its CSR activities under 12 broad heads, and they are as follows:



## **Functioning of CSR at NRL**

NRL, since its inception, has been continually working for the upliftment of society through its persistent developmental efforts through different community development schemes.

NRL engages with the community at the village, panchayat or district level for the implementation of its various projects on a regular basis. This has helped the Company in identifying most of the projects implemented so far. Regular dialogues and meetings are held with key stakeholders directly by the CSR team to ascertain their needs and requirements, and most development works are done through community-forums such as Village Development



Committees, School Management Committees etc. A CSR and Sustainability Steering Committee is responsible for planning, actual implementation and monitoring of CSR and Sustainability activities.

Once the projects/schemes are identified through a two-tier organizational structure, comprising a CSR and Sustainability Committee of the Board at the apex level and a CSR and Sustainability Steering Committee at the execution level, proposals are processed in an E- platform called "e-SEWA".

The CSR department releases a Monthly report which is uploaded to the intranet portal, and a quarterly update is published on the NRL website. The Board level CSR committee conducts half yearly & yearly reviews of the CSR projects.

NRL regularly conducts Impact Assessment studies by engaging third parties to measure the impact of its major CSR & Sustainability activities. These studies have vindicated the positive impact of NRL's CSR efforts in the region and have also provided inputs for fine-tuning future projects to further increase the welfare of target beneficiaries.

The execution of major projects follows a transparent, project-based approach, and the annual budget is allocated based on 2% of the average profit-before-tax of the preceding three years. CSR initiatives are structured through a two-tier organizational framework, ensuring effective communication, monitoring, and periodic evaluation. The policy highlights a local focus within a 10 km radius of NRL's operations, limiting administrative overheads to 5% of the annual CSR budget.

**Project brief:** Addressing multiple objectives of Women's empowerment, Skill Development, Healthcare, and Employment generation, the VK-NRL School of Nursing is a flagship institute offering a 3-year Diploma in General Nursing and Midwifery. This program is offered free of charge to meritorious underprivileged girls from various parts of Assam.

We have also made a unique effort at reducing Elephant-man conflict whilst increasing the green cover at Bogidhola Muga VGR in Sumoni GP.

This high-tech yet grounded project helps local producers to increase the shelf-life of their produce thereby enabling them to fetch better market prices. The entire facility is powered by solar energy and is IoT-connected thereby introducing modern clean energy technology in the region.

## **Dusutimukh Primary Healthcare Centre**

#### Access to World-Class Healthcare Facilities, Even in the Remotest Regions

**Project brief:** Despite the remoteness of the region, which is often affected by floods during the monsoon months, residents of Dusutimukh, a large percentage of whom are the Tribal Mising community, now enjoy access to world-class healthcare facilities with NRL equipping its PHC with the latest medical equipment.
