Please note our following reply:

- A total of 3512 nos. of Tarpaulin sheets were distributed among affected villagers of nearby areas of the refinery due to hailstorm occurred on 9th January, 2016. List of villages where tarpaulin were distributed is attached as Annexure-I.
- As distribution took place on urgent basis, no record of beneficiaries were kept. However distribution was done in co-ordination with local social organizations of respective areas.
- Considering the immediate nature of requirements, verbal order was placed to two parties based on quotations collected from suppliers at Golaghat and Jorhat.
- An amount of Rs. 70.05 lakhs was incurred for distribution of tarpaulin sheets among hailstorm affected people. Approval copy is attached as Annexure-II.
