1. The instant Appeal is preferred against an order issued by the following Public Information Officer ("PIO"):-

Dr. Kajal Saikia

Public Information Officer, NRL

2. The Appeal arises from an order issued vide letter dated 15.06.2023 bearing Ref. No. NRL/CPIO/RTI/Q-1976. The said letter was received by the undersigned only on 28.06.2023.
3. The undersigned had submitted his application dated 01.06.2023 seeking certain information regarding allocation of Raw Petroleum Coke by the Numaligarh Refinery Limited ("NRL"), none of which are contemporaneous and are in fact, mostly general in nature.
4. Vide the impugned order issued vide letter dated 15.06.2023 (at reference ii), the PIO has refused to provide information against the questions at Sl. Nos. 3 to 8 on the sole ground that the said information is commercial information of a third party, and as such, barred by Section 8(1)(d) of the Right to Information Act, 2005. The said paragraph is extracted hereinbelow for convenient reference: -



*Information cannot be shared as it falls under 8(1)(d) of RTI act of 2005 related to commercial confidence of a third party.*

5. By way of the instant appeal, the undersigned humbly prays that the information sought at Sl. Nos. 3 to 8 (enumerated in the impugned order dated 15.06.2023) be released, for the grounds taken in the following paragraphs.
6. That, the information sought at Sl. Nos. 3 to 8 (enumerated in the impugned order dated 15.06.2023), is not barred from disclosure under the RTI Act, for the following grounds: -
  - A. The PIO has omitted to note that the information sought for at Sl. Nos. 3 to 8 is not in the nature of "information related to commercial confidence of a third party" for the reason that the information sought either pertained to concluded transactions (where a Public Sector Undertaking was a party) or were general data related to production of natural resources by a Public Sector Undertaking. It is settled law, following several decisions of the Hon'ble Supreme Court, various High Courts and the Central Information Commission, that data pertaining to such categories are not prohibited by any provision of the RTI Act. This is primarily in view of the fact that PSUs like the NRL are State entities for the purposes of Article 12 of the Constitution of India.
  - B. Even accepting on a demurrer that the information sought for was in the nature of "information related to commercial confidence of a third party", the PIO has omitted to take into account the proviso to Section 11(1) of the RTI Act which provides that except in the case of trade or commercial secrets protected by law, disclosure may be allowed if the public interest in disclosure outweighs in importance any possible harm or injury to the interests of such third party, as in the instant case.
  - C. The grounds as against each question at Sl. No. 3 to 8 are adduced in the form of the following table, and may read as a part of the appeal: -






