# **PRE-QUALIFICATION CRITERIA:**

- A. **Past Experience** of having **successfully completed** similar works\* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
  - > One similar work costing not less than = Rs. 78.00 Lakhs
  - **Two** similar works costing not less than = **Rs. 62.50 Lakhs each** and
  - > Three similar works costing not less than=Rs. 46.80 Lakhs each.

## Similar Works: Design, Fabrication, Supply, Erection, Installation and Operation of V-Type Unipole Display.

### The bidder has to submit details SOR and completion certificate of executed job in support of the same.

➢ Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and thereafter at @0.58% for every completed month ending last day of the month proceeding the month in which last date of original bid submission falls.

#### B. Average Annual Turnover: During the last 3 financial years, shall be at least Rs. 46.80 Lakhs.

- Note: Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
- > Net worth: The Net Worth of the Bidder in the immediate preceding financial year shall be positive.
- Bidder should not be under liquidation, court receivership or similar proceedings. Bidder shall submit a self-certificate to this effect.

#### **C.** <u>Possession of Valid GST registration certificate</u>:

Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.
