A. <u>BRIEF SCOPE OF WORK:</u> As per Tender Document, SCC, Technical Tender document and SOR.

**B.** The relaxation of Prior Turnover and Prior Experience (Indicated in the tender document) will not be applicable for Micro and Small Enterprise (MSE) or Startup bidder for the subject tender as it is related to critical equipment and public safety. As such Pre-Qualifying Criteria mentioned in the tender should be complied by all participating bidders.

### C. PRE-QUALIFICATION CRITERIA:

- 1) The bidder must have specific experience of working on Governing system of STG. The bidder must submit documentary evidence along with the offer in the form of work order/work completion certificate and Performance certificate of successful overhauling/maintenance/calibration of Governing system of STG in the last five years from the tender date in India.
- 2) **Past Experience** of having successfully completed similar works\* during last 10 years ending last month should be either of the following:-
  - ➤ One similar work costing not less than **Rs.4.82** \* **Lakh** or
  - > Two similar works costing not less than **Rs.3.86**# **Lakh** each or
  - ➤ Three similar completed works costing **Rs.2.89 Lakh** each

<sup>\*</sup> **Similar works:** The party must have sufficient & capable workforce having hands on experience of working on machineries as per Annexure –I (For Annexure-I, Refer attached technical tender document) or similar machineries in the last ten years from the tender date in India. Documentary evidence in support of the same in the form of work order and work completion certificate to be submitted along with the unprice bid. The bidder shall also submit detail information of service provided in turbines, compressors and gear boxes covered under such orders. If such information is not appearing in the work order, same shall be submitted in a separate sheet mentioning the work order number dully vetted by EIC.

- 3) Minimum qualification & experience required on machineries as per Annexure-I (For Annexure-I, Refer attached technical tender document) or similar.
  - a. **Expert:** Ex BHEL, employee having B.E /Diploma in mechanical Engineering with minimum 15 years of hands on experience in troubleshooting and overhauling of equipment at M/s BHEL as per Annexure-I
  - b. **Engg/Assistant: (i)** B.E with 03 years of experience.
    - (ii) Diploma in Engineering with 07 years of experience..
      - (iii) ITI with 10 years of Experience.

The bidder shall provided adequate documentary evidence in support of qualification and experience along with the offer.

4) The party must be capable to depute up to 03 personnel (Expert+ Engg. /Assistant) at the same time for simultaneous works at different units of the refinery or different nature of job in the same equipment (e.g. overhauling of compressor, turbine, gear box in the same equipment) during RTA or emergency.

\*The Value of past experience be adjusted at a simple rate of 7% for every completed year and/ or part thereof ending last day of the month preceding the month in which bids are invited

**Note:** The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria.

5) Average Annual Financial Turnover during the last three years ending 31<sup>st</sup> March of the previous financial year, shall be at least **Rs.2.89 Lakh.** The bidder must submit copy(ies) financial documents – Trading and P/L account(s) along with the un-priced bid in support of the above criteria.

Bidder should have following valid documents to be submitted along with the technical Bid on the date of Closing of tender.

- a) Income Tax PAN number.
- b) GST registration number.
- c) PF & ESI certificate.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.

# G. Procedure or Process for Online Submission of EMD:

- Bidders will open the link <a href="https://easypay.axisbank.co.in/nrl">https://easypay.axisbank.co.in/nrl</a> and type the Tender ID (OC16000297) for which EMD is to be paid and click on the option "Validate".
- 2. The web page will auto populate Tender Name, Last Date of Payment, Bid Opening date and EMD (not editable).
- 3. The bidder will enter his Company/ Firm Name, Address, e-Mail ID, Amount and Mobile Number.
- 4. The bidder is also required to enter his preferred account No. and IFS Code twice for receiving EMD refund. In case of any mismatch in the account No. or IFS Code entered twice, the web page will prompt the bidder to correct the data and then allow proceeding with payment.
- 5. The Bidder is then required to enter verification code as displayed in the web page and click on the option "Submit".
- 6. The next Web Page will then display the summary of the EMD payment along with a Unique Reference Number (URN).
- 7. Bidder is required to accept the payment Terms and Conditions and select his preferred mode of payment from the options provided, viz., Net Banking (Axis Bank or Other Banks), Credit/ Debit Cards or NEFT/RTGS.
- 8. In case of Net Banking, the bidder will enter his User ID/ Password/ Transaction Password and One time password as per the online payment system of the Bidder's Bank.
