PRE-QUALIFICATION CRITERIA:-

The subject job being 'Work Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

- A) Past Experience of having successfully completed similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
 - ➤ One similar work costing not less than Rs.170.87 Lakhs
 - Two similar works costing not less than Rs.136.70 Lakhs each and
 - ➤ Three similar works costing not less than Rs.102.52 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

*Similar Works: Bidders should have experience of successfully completing either 1. CIVIL / Building AMC jobs 2. Civil / Building nature maintenance job

B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.102.52 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
