PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

The intending bidders for above tender should meet all the qualification criteria given below:

- **A) Past Experience** of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - ➤ One similar work costing not less than Rs.34.50 Lakhs, or
 - **Two** similar works costing not less than **Rs.27.60 Lakhs each**, or
 - ➤ Three similar works costing not less than Rs.20.70 Lakhs each.

Note: Relevant work order copies and corresponding job completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

*Similar Works: Bidder must have experience of executing mechanical nature of job which includes column related maintenance job in any Crude Oil Refinery/ Petrochemicals during last ten years ending last month from date of tender. Proof of experience - work orders against completed jobs and corresponding completion certificates are to be furnished. In case of a composite/ LSTK shutdown / Refinery turn around contract, executing mechanical nature of job which includes column related maintenance job to be clearly mentioned in the scope/ SOR of work order submitted by the bidder as a proof of experience. However, during bid evaluation total work order value (completed job) containing the above-mentioned job shall be considered.

B) AVERAGE ANNUAL TURNOVER, of the last 3 financial years, shall be at least Rs.20.70 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate
