#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar

proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 4. Buyer Added Bid Specific ATC

#### **PRE-QUALIFICATION CRITERIA (PQC):**

The The bidders who intend to participate in the tendering process shall meet the following requirement:

Bidder shall have successfully executed and completed supply and installation of small form factor PCs or mini PCs or desktop PCs, laptop etc. or Digital Display Boards at any Oil & Gas/ Govt. sector/ Reputed Priva te Organizations in India during last 5 (five) years from the date of notice inviting tender (NIT).

Copy of purchase/work order and completion certificate containing the job description, item details, date of order, ordered value awarded in the name of bidder by client should be submitted along with the offer.

#### Additional points:

- 1. The Bidder, as a single legal entity, must be registered in India and should have been in operations in India for a minimum of three (3) years by the date of opening of the bid. Copy of certificates of incorporation or Registration Certificate to be submitted.

Consequently, the bidder is o bligated to dispatch its installation team multiple times, in accordance with the directives of the Engineer-in-Charge (E-I-C). The bidder is advised to anticipate a minimum of five distinct visits by the installation team and to incorporate associated expenses into their quotation accordingly. This section shall be read in conjunction with any other relevant sections/provisions of this document. In case of ambiguity, the decision of E-I-C shall be final and binding on the bidder.

#### 7. Guaranty / Warranty:

Vendor shall provide **minimum three-year valid on-site warranty** for all items from the date of succes sful commissioning and acceptance at Site. During the warranty period, vendor shall be liable for uninterru pted availability of the system.

During the warranty period, vendor shall provide Periodic preventive Maintenance visits by competent OE M or OEM authorized technician per year which will include inspection and servicing. A minimum of 2 vis its per anniversary year shall be provided by the bidder. Bidder to note the same and quote a ccordingly.

If any malfunction is reported during warranty period, based on the nature of the problem, vendor shall arrange for rectification within 7 days from the date of intimation and without any additional financial implications to NRL.
