BRIEF SCOPE OF WORK: As per Technical Tender Document (Doc. No.: MM/INT COATING/Service /01/2019), SCC, Tender document and SOR.

PRE-QUALIFICATION CRITERIA:

1. Bidder must be a manufacturer or authorized dealer (Valid and up to date dealership certificate to be submitted) cum applicator for executing internal coating of pipes of minimum dia. 4 inch with glass flakes in any Hydrocarbon Industry.
2. The bidder shall have experience of internal coating of piping and erection job conforming to Sa2 ½ for surface preparation jobs.
3. The bidder must submit copies of relevant work orders, SOR and completion certificates in support of this criterion, for the jobs done during last ten years ending last day of month preceding enquiry floating date.
4. **Past Experience** of having successfully completed similar works* during last 10 years ending last day of the month, proceeding the month in which bids are invited should be either of the following :-
 - One similar work costing not less than **Rs.17.07[#] Lakh** or
 - Two similar works costing not less than **Rs.13.66[#] Lakh** each or
 - Three similar completed works costing **Rs.10.24[#] Lakh** each

***Similar works:** "Experience of Internal protective coating of pipe and joint of 4 inch diameter with 100% solvent free matrix of Isophthalic polyester resin, high build coating system with laminar glass flake in hydrocarbon or petrochemical industries." Work order copy along with job completion certificate to be submitted along with unpriced bid.

[#] *The Value of past experience be adjusted at a simple rate of 7% for every completed year and/ or part thereof ending last day of the month preceding the month in which bids are invited*

Note: The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria.

5. Average Annual Financial Turnover during the last three years ending 31st March of the previous financial year, shall be at least **Rs.10.24 Lakh**. The bidder must submit copy (ies) financial documents – Trading and P/L account(s) along with the un-priced bid in support of the above criteria.
6. Bidder should have following valid documents to be submitted along with the technical Bid on the date of Closing of tender.
 - (i) Income Tax PAN number.
 - (ii) GST registration number.
 - (iii) PF & ESI certificate

SPECIAL NOTE TO BIDDERS:

The relaxation of Prior Turnover and Prior Experience (Indicated in the tender document) will not be applicable for Micro and Small Enterprise (MSE) or Startup bidder for the subject tender as the service are related to public safety, health & environmental safety. As such Pre-Qualifying Criteria mentioned in the tender document should be complied by all participating bidders.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt. Procedure or Process for Online Submission of EMD:

1. Bidders will open the link <https://easypay.axisbank.co.in/nrl> and type the Tender ID for which EMD is to be paid and click on the option "Validate".
2. The web page will auto populate Tender Name, Last Date of Payment, Bid Opening date and EMD (not editable).
3. The bidder will enter his Company/ Firm Name, Address, e-Mail ID, Amount and Mobile Number.
4. The bidder is also required to enter his preferred account No. and IFS Code twice for receiving EMD refund. In case of any mismatch in the account No. or IFS Code entered twice, the web page will prompt the bidder to correct the data and then allow proceeding with payment.
5. The Bidder is then required to enter verification code as displayed in the web page and click on the option "Submit".
6. The next Web Page will then display the summary of the EMD payment along with a Unique Reference Number (URN).
7. Bidder is required to accept the payment Terms and Conditions and select his preferred mode of payment from the options provided, viz., Net Banking (Axis Bank or Other Banks), Credit/ Debit Cards or NEFT/RTGS.
8. In case of Net Banking, the bidder will enter his User ID/ Password/ Transaction Password and One time password as per the online payment system of the Bidder's Bank.
9. For Credit/ Debit Card payment, the Bidder will enter his Card Number, Expiry Date, CVV and 'Verified by VISA' or 'Master Secure' password as applicable.
10. For bidders selecting the payment option of NEFT/ RTGS, the web page will generate a challan with a Dynamic/Virtual Account Number, IFS Code, Account Name and Amount. The bidders can take a print out of this challan or just note the relevant details and initiate the NEFT payment from their Bank.
11. A receipt will be generated after successful payment (irrespective of the mode of payment). Bidder can take print out for onward submission with tender as well as save a soft copy of the receipt.
