ii) PART - II : Price Bid

- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- iv) Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.
- v) Corrigendum, Addendum (if any) will be published in e-tendering portal (http://eprocure.gov.in/eprocure/app) only.
- 3. **EARNEST MONEY DEPOSIT:** Not applicable.
- 4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

5. **PRE-QUALIFICATION CRITERIA (PQC):**

- a. The bidder must be a reputed manufacturer of ammonium polysulfide as per our specification. If the bidder is not a manufacturer of ammonium polysulfide, the bidder must be an authorized dealer of the concern manufacturer. In this regard, copy of valid authorization certificate to be attached with the offer.
- b. The bidder must provide references regarding supply of ammonium polysulfide for Hydrocracker unit. The details references including the copy of the purchase order to be attached with the offer. **Minimum one reference of supply for Hydrocracker unit of Indian Refinery**.
- 6. The requirement of Prior Turnover and Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.

<u>Supporting documents for MSE bidders:</u> Please refer Annexure-X enclosed.

<u>Supporting documents for Startup:</u> Bidder who intends to participate as 'Start-up' company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India.

<u>Note:</u> Above supporting documents are required to be uploaded by bidder along with un-priced techno-commercial bid only. It is the responsibility of the bidder to upload the above supporting documents along with their un-priced techno-commercial bid for availing relaxation on Prior Turnover and Prior Experience (if applicable in this tender). In case of non-receipt of above documents along with bidder's un-priced bid, no further communication in this regard will be carried out to ascertain bidder's qualification as 'MSE bidder/ Startup' and relaxation on Prior Turnover and Prior Experience (if applicable in this tender) will not be passed on to bidder.

- e) MSE bidder may submit EM (Part-II)/ UAM wherein bidder is registered as 'Micro/ Small Enterprise' [refer Annexure-X enclosed]
- f) In case of availing benefits under Purchase Preference Policy (Linked with Local Content) (PP-LC Policy), bidder to submit documents as per PP-LC Policy and 'Table 1: Calculation of Local Content Supply Contracts (Goods)' (i.e. Page 5 of 7 of PP-LC Policy) to be stated as 'QUOTED IN PRICED BID'
- g) Vendor Details as per Format enclosed.

8. DOCUMENTS TO BE SUBMITTED AS A PART OF PART – II: PRICED E-BID:

- BoQ/Priced Bid "in "XLS" format as per instructions provided.
- In case of availing benefits under Purchase Preference Policy (Linked with Local Content) (PP-LC Policy), bidder shall provide break up of "Local component" and "Imported Component" along with their price bid (in PDF) as per format in 'Table 1: Calculation Of Local Content Supply Contracts (Goods)'; refer page 5 of 7 of PP-LC Policy.
- 9. EVALUATION OF THE TENDER: Tender shall be evaluated on 'Lowest Offer Basis'.
- 10. TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs): Refer Annexure-X

11. **GENERAL**:

i) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credential against PQC. Authentication may be verified with the issuing authorities, by way of direct communication to NRL over official e-mail IDs / Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.

Proper address for communication, including e-mail ID of the issuing authority should be provided along the tender document.

- ii) Consortium/Joint venture bids shall not be accepted.
- iii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iv) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- v) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
