2. NRL cannot provide information on crops compensation details to third party without the consent of Individuals farmers, in accordance with the regulation outlined in 8(1)(j) of RTI .

Q.N.1 Is there any extension procedure going for the NRL new plant?

Reply: Your question is not specific and does not help us identify the information in question. To enable us to provide a meaningful and accurate response, we request that you kindly clarify the following:

- The specific details or records you are seeking related to the "extension procedure."
- Any particular project, department, or process at NRL you are referring to.

Once we receive the above clarifications, we will try to reply to the best of our ability as per the provisions of the RTI Act.

Q.N.2 How many cost bearing for the completion of the new extension project?

Reply: Although your question is not clear, we are providing the following information to the best of our understanding:

At present, there is an integrated project in NRL with 3 components:

- A new refinery train of 6 MMTPA in existing plot at Numaligarh.
- Crude Oil pipeline from Paradeep to Numaligarh (9 MMTPA, 1398 KM).
- Product pipeline from Numaligarh to Siliguri (6 MMTPA, 609 KM)

This project will be carried out at a Project Cost of Rs. 22,594 Crore which was accorded approved by the Cabinet Committee of Economic Affairs on January 16, 2019.

On October 07, 2021, MoPNG approved Revised Refinery Expansion Project Cost of Rs. 28,026 Crore.

Q.N.3 Who is the Funding Agency for NRL new plant? What is the terms and conditions of the financing agency? Is NRL mortgage any NRL property for that?

For your information, NRL is currently engaged in the construction activities related to the Numaligarh Refinery Expansion project and the same entails the following units:

- Crude Distillation Unit (CDU)/Vacuum Distillation Unit (VDU)
- Diesel Hydrotreater (DHT)
- Sulfur Recovery Block
- Utility and Offsites
- Resid Processing and Treating Unit (RPTU)
- MSP (NHT/CCR/ISOM)
- Gasoline Desulfurization (GDS)
- Petro FCC (PFCC)
- Hydrogen Generation Unit (HGU)

Simultaneously, the crude pipeline project is also under construction.

As per the Annual Report 2023-24, the Company's Debt Equity ratio at the close of the financial year stood at 0.58. There is an increase in the Total Borrowings of the Company. The Total Borrowings of the Company as on 31st March 2024 stood at ₹7,982.98 Crore, as against ₹2,988.85 Crore as on 31st March 2023.

The Company has entered into a Rupee Term Loan facility agreement for ₹18,904 Crore with a consortium of twelve Indian Banks on 30.12.2021 for expansion of its Refinery capacity. The applicable interest rate on term loan is linked to SBI 6 months MCLR. The repayment schedule of the term loan is in 44 equal quarterly installments which shall start from 31.12.26. There has been no default in payment of interest on term loan. Security on assets of the company has been created on 30.12.21 by executing the deed of hypothecation. The necessary charge documents have been filed with the Registrar of Companies, Guwahati.

Further the company has also executed the indenture of mortgage by way of first charge on Plant, Property and Equipment of project towards perfection of security as per the provisions of the facility agreement. The indenture of mortgage has been adjudicated/registered on 30.12.21 and charge has also been registered with Registrar of Companies, Guwahati on 07.01.22.

The Numaligarh Refinery Expansion Project is being established in the existing refinery location at the following address:

For execution of the project at Numaligarh Location, NRL has acquired a parcel of land measuring 600 bigha in Rajabari Tea Garden adjacent to the Refinery boundary wall through Govt of Assam for a value of Rs 79.58 Cr. Additionally, NRL also acquired 362 bigha of land in Dabidubi in Khumtai Mouza for a value of Rs 20.93 cr through Govt of Assam.

The pipeline component of the project is a 1635 Km crude pipeline traversing through 5 states from Paradip in Odisha, via Jharkhand, Bihar, West Bengal and Assam and NRL has acquired Right of Use (ROU) for the pipeline route. Out of the total pipeline distance, NRL has acquired fresh right of use (ROU) for 716 Km and balance 919 km has been shared with the ROU available with other companies. The compensation amount for the ROU is decided by respective competent authority engaged for State Govt and NRL pays as per the directive of the authority.
