My email on August 16, 2025, which explicitly warned of Section 20 (1) penalties, was completely disregarded.

#### 2. Insufficient and Misleading Information

The CPIO's reply is an example of evasion. My requests for specific, item-wise breakdowns—from the Rs. 5,875 Crore cost escalation to the full expenditure details—were met with vague summaries and high-level tables. This is a clear violation of Section 7 (1). By concealing crucial details, the

### ORDER

- A. This appeal has been filed by Ms. Umme Salma Hassan under Section 19(1) of the RTI Act, 2005 against the reply of the Central Public Information Officer (CPIO), NRL, to her RTI Application No. NRLTD/R/E/25/00022 dated 24.07.2025.
- B. The Appellant has raised the following principal grievances in her First Appeal:
- That the CPIO deliberately provided an incomplete and evasive reply despite having sufficient time under Section 7(1) of the RTI Act.
  - That no certified copies of documents such as feasibility reports, approval orders, and project cost details were provided, in violation of Section 2(f).
  - That her request for item-wise cost breakup of the Rs. 5,875 Crore cost escalation, CSR expenditure details, and accountability of officers was met with vague references and website links, contrary to Section 7(1).

- d. That the CPIO wrongly invoked exemptions under Section 8(1)(d) (commercial confidence) and 8(1)(j) (personal information) without justification, despite the overriding public interest in disclosure under Section 8(2).
- e. That she was not provided information in the specific format requested (certified copies uploaded on the portal), which she claims is a violation of Section 7(9).

**C. The relief sought by the Appellant includes:**

- a. Directions to provide all requested information including certified documents, detailed cost breakups, and names of responsible officers.
- b. Rejection of exemptions claimed by the CPIO.
- c. Consideration of penalty proceedings against the CPIO under Section 20(1) & (2).
- d. Compensation for inconvenience under Section 19(8)(b).

**D. The CPIO, in response, has furnished information available on record to the extent permissible. The CPIO has:**

- a. Provided project-related information and expenditure details through tables and references already available in the public domain.
- b. Referred the Appellant to official NRL disclosures and website content for CSR and administrative expenditure details.
- c. Declined to provide names of individual officers, citing Section 8(1)(j), and withheld certain project details under Section 8(1)(d) as commercially sensitive.
- d. Not provided certified copies on the ground that the available information was already disclosed through authentic digital means.

## Record of CPIO's Replies

### Chapter I: Project Cost Determination & Financial Transparency

1. In response to the query regarding the initial estimated project cost and feasibility reports, the CPIO provided a breakup of project cost elements for the original approved cost and Revised Cost Estimate (RCE-I). A summary table was shared, and a link to the Executive Summary of the Detailed Feasibility Report (DFR) available on the Environment Clearance portal was provided. Certified copies were not furnished.
2. Regarding the sanctioned project budget and approvals, the CPIO stated that the original project cost of ₹22,594 Crore was approved by the Cabinet Committee of Economic Affairs (CCEA) on 16.01.2019. The Revised Cost Estimate (RCE-I) of ₹28,026 Crore was subsequently approved by the Ministry of Petroleum & Natural Gas (MoP&NG) on 07.10.2021. The further revised estimate (RCE-II) of ₹33,901 Crore has been submitted to MoP&NG and remains under active consideration. Copies of approval orders were not furnished.
3. On the reasons for escalation from ₹28,026 Crore to ₹33,901 Crore, the CPIO attributed the increase to: (i) rise in commodity prices amounting to ₹3,809 Crore, (ii) revision in specifications post detailed engineering amounting to ₹657 Crore, (iii) depreciation of INR against USD of ₹117 Crore, and (iv) revision in soft costs including interest during construction.

### Chapter II: Deconstruction of Project Cost Calculation & Tender Estimates

1. In reply to the request for methodology of project cost calculation, the CPIO stated that the original cost was based on a DFR prepared by Engineers India Limited (EIL) and that RCE-I was prepared by Deloitte. The estimation used industry norms for refinery, pipeline, and crude terminal units, along with financial modelling based on a 70:30 debt-equity ratio and Viability Gap Funding of ₹1,020 Crore. An item-wise breakup of project cost was shared. The names of officers were not disclosed.
2. On tender estimate methodology, the CPIO explained that such estimates are confidential internal documents prepared for benchmarking and cost control. Disclosure of these details, including rate calculations and names of personnel, was denied on the ground of Section 8(1)(d) of the RTI Act, since such information constitutes commercial confidence and its

disclosure could harm the competitive position of the company and third parties.

3. With respect to profit margins for contractors, the CPIO clarified that contracts are awarded on the basis of the lowest (L1) bidder in compliance with CVC guidelines, and no predetermined profit margins are used. The internal calculations and methodologies used were withheld, being confidential and exempt under Section 8(1)(d).

### Chapter III: Project Completion Timeline & Accountability for Delays

1. The CPIO informed that the original completion period for the expansion project was 48 months from the date of statutory approvals. Based on Environmental Clearance received in July 2020, the project was initially to be completed by July 2024. Due to the COVID-19 pandemic, global supply chain disruptions arising from the Russia-Ukraine conflict, commodity price fluctuations, delays in tender submissions, and litigation in the PFCC package, the completion schedule was extended by 17 months, making the revised COD December 2025. The internal planning documents relied upon were not disclosed, citing Section 8(1)(d).
2. On whether the project is on track for revised CODs, the CPIO confirmed that commissioning is targeted for December 2025. To the question of further delays, it was replied that the project remains on track as per the approved schedule.
3. Regarding accountability of officers, the CPIO stated that the project execution involves multiple departments, contractors, consultants, and agencies, and that responsibility is collective. No single officer could be held solely responsible for delays.
4. As to disciplinary or penal actions, it was stated that contractors are subject to penalties as per contract provisions, which may include financial penalties or short closure of contracts. However, details of specific actions, including orders and names of competent authorities, were not furnished, being confidential and exempt under Sections 8(1)(d) and 8(1)(j). No NRL officer was held individually accountable for delays.

### Chapter IV: Project Cost Escalation & Financial Accountability

1. The CPIO informed that the total expenditure incurred as on 31.07.2025 was ₹26,204 Crore.


2. On the issue of cost overrun beyond the revised estimate of ₹33,901 Crore, the CPIO replied that the query was “not applicable.”
3. For the names of officers or contractors responsible for cost overruns, the CPIO referred back to the earlier reply under Chapter III (Q.2(c)), reiterating that responsibility is collective.
4. On disciplinary or recovery action, the CPIO again referred to the reply under Chapter III (Q.3), stating that no individual officers were held accountable, and details of contractual actions were withheld under exemptions.

#### Chapter V: Scrutiny of Administrative Expenses – Party Arrangements & Meals

1. The CPIO categorically replied that as per records, no funds were utilised by NRL for “party arrangements” for officers, including senior management.
2. Similarly, it was replied that no NRL funds were utilised for “breakfast, lunch, or dinner” expenses of officers outside their entitled allowances.
3. Consequently, queries on policies or violations regarding such expenditures were answered as “not applicable.”

#### Chapter VI: Corporate Social Responsibility, Local Development Initiatives & Donations


1. In respect of CSR and local development initiatives since 2015, the CPIO explained that activities are undertaken under five thematic areas: livelihood generation, education/skill development, infrastructure, healthcare, and promotion of arts/culture. These are aligned with DPE priorities and NITI Aayog’s aspirational districts framework. Details of initiatives, budgets, payments, and authorisations are available on NRL’s website. The methodology of budgeting was explained (need assessments, proposals, vetting, approvals). Payment records are maintained in the CSR Cell. Policies and guidelines are available online. Due to the large volume of data, inspection at NRL’s office was offered instead of providing hard copies.
2. On donations made by NRL since 2015, the CPIO replied that NRL has not made any donations (financial or in-kind) under CSR.



3. On separate or additional donations, it was again stated that NRL has not made any donations (financial or in-kind).

**E. After a detailed examination of the records and submissions, the following findings are recorded:**

- a. The RTI Act provides access to "information" as defined under Section 2(f), which covers records, documents, and data available with the public authority. However, queries seeking justifications, explanations, or opinions (e.g., reasons for project delays or officer accountability) do not fall within this definition. A person seeking information under the RTI Act, cannot seek explanations or justifications or the reasons as to why certain actions were taken by the authority concerned and therefore, the undersigned is of the considered opinion that the CPIO has not violated any provision of the RTI Act in not disclosing the information, as detailed hereinabove.
- b. The CPIO has shared information in the form available and has directed the Appellant to the NRL website for CSR and expenditure details, which is consistent with Section 7(1) read with Section 4(1)(b) obligations. If the information sought for is available in the public domain and in some website, accessible to all, there is no illegality in relegating the person seeking information, to the said website and the undersigned finds that the CPIO has not committed any violation of the provisions of the RTI Act.
- c. The exemptions invoked under Section 8(1)(d) and 8(1)(j) are justifiable in the context of sensitive commercial information and personal details of officials. The Appellant's reliance on "*public interest override*" under Section 8(2) is noted, but no larger public interest warranting disclosure has been established in this case. Merely making a statement that the public interest would override the disclosure of the information would not suffice and the appellant has failed to disclose any such overriding public interest, warranting the disclosure of the sensitive commercial information and personal details of the officials concerned.
- d. Certified copies were not issued as the information was already in the public domain and accessible to the Appellant. The Act does not mandate duplication of information already proactively disclosed.



F. Accordingly, it is held that the reply of the CPIO is in compliance with the RTI Act, 2005, and no intervention is required by the First Appellate Authority.

## DECISION

The First Appeal filed by Ms. Umme Salma Hassan vide Registration No. NRLTD/A/E/25/00007 is **rejected**.

The Appellant, if aggrieved by this decision, may prefer a Second Appeal before the Hon'ble Central Information Commission under Section 19(3) of the RTI Act, 2005 within the prescribed time limit.

### ORDER

1. The present Appeal has been preferred by the Appellant under Section 19(1) of the Right to Information Act, 2005 ("the Act") against the response furnished by the Public Information Officer (PIO), Numaligarh Refinery Limited (NRL), in relation to RTI Application No. NREFL/R/E/25/00007 dated 24.07.2025.
2. The Appellant has, inter alia, contended that the PIO deliberately backdated the reply, dispatched the response belatedly, and denied disclosure of information concerning Assam Bio Ethanol Private Limited

(ABEPL)/ABRPL on untenable grounds. The Appellant has further prayed for directions of full disclosure, imposition of penalty under Section 20 of the Act, initiation of inquiry into the PIO's conduct, and award of compensation.

3. I have carefully perused the RTI Application dated 24.07.2025, the reply of the PIO dated 06.08.2025 (dispatched on 12.08.2025), and the submissions made in the present Appeal. The following points arise for determination:

- (i) **Whether the PIO's reply was within the statutory time limit prescribed under Section 7(1) of the Act?**
- (ii) **Whether ABEPL/ABRPL constitutes a "public authority" under Section 2(h) of the Act?**
- (ii) **Whether NRL, as a shareholder, is obligated to disclose information relating to ABEPL under Sections 2(f) and 2(j) of the Act?**
- (iii) **Whether grounds exist for imposing penalty under Section 20 or granting compensation under Section 19(8)(b) of the Act?**

### **Findings**

4. On the first issue, the record discloses that the RTI Application was filed on 24.07.2025 and the statutory period of 30 days expired on 23.08.2025. The PIO issued a reply dated 06.08.2025, which was dispatched on 12.08.2025. The same falls well within the period stipulated under Section 7(1). The contention of "delay" or "backdating" is therefore not



established. Minor administrative delay in dispatch by post does not amount to violation of Section 7(1).

5. On the second issue, Section 2(h) of the RTI Act defines "public authority" as any authority or body established or constituted by or under the Constitution, law made by Parliament or State Legislature, notification or order of the Government, or any body owned, controlled, or substantially financed by the Government. ABEPL/ABRPL is a Joint Venture Company incorporated under the Companies Act, 2013, wherein NRL, a PSU, holds 50% equity. However, mere equity participation or business collaboration does not, ipso facto, render a private company a public authority. The Hon'ble Supreme Court in *Thalappalam Service Coop. Bank Ltd. v. State of Kerala*, reported in (2013) 16 SCC 82, has categorically held that "control" under Section 2(h) must be deep and pervasive, and mere supervisory or shareholder rights are insufficient. Hence, ABEPL/ABRPL cannot be treated as a public authority.
6. On the third issue, it is evident that the information sought by the Appellant pertains to the internal functioning and records of ABEPL/ABRPL. NRL does not maintain such records in the ordinary course of its statutory functions. The RTI Act obligates disclosure of information "*held by or under the control of*" a public authority. Since the requested records are not held by NRL in material form, nor under its statutory control, there arises no obligation upon the PIO to procure and disclose the same.
7. On the fourth issue, since the reply was furnished within time and based on a reasonable interpretation of the law, there is no evidence of malafide or wilful obstruction. The requirements for invoking penalty under Section



20(1) or (2) are not satisfied. Similarly, the prayer for compensation under Section 19(8)(b) does not merit acceptance.

8. In light of the above discussion, it is hereby ordered as follows:

(a) The appeal is **dismissed**.

(b) The reply furnished by the PIO vide letter dated 06.08.2025 is upheld.

(c) No further directions are issued with respect to disclosure, penalty, or compensation.

9. The Appellant, if aggrieved, is at liberty to prefer a **Second Appeal before the Hon'ble Central Information Commission (CIC), New Delhi**, under Section 19(3) of the RTI Act, 2005, within the prescribed period.

Numerous judicial precedents confirm that income details cease to be purely private when necessary for a court to determine a financial obligation. I am providing an example to this. High court affirmation (e.g. Sunita Jain vs. Pawan Kumar Jain MP High Court &amp; V.A. Anand vs. State Information Commissioner Madras High Court) (Are emphatic holding: The courts dismissed the husbands plea that his salary details are protected by privacy under Section 8(1)(j). The Rationale (The allowed part of the RTI): The high courts held that the wife is entitled to know the remuneration her husband is getting, emphasizing that the husband and wife share a sacrosanct relationship and that his financial details are necessary for the court to determine a just and fair amount of maintenance. This necessity creates the larger public interest exception. Not only this there are numerous more Supreme court rulings as well. By withholding the information, the CPIO is directly obstructing the judicial process. Moreover, I kept on waiting for the enquiry by the CPIO side on my contact number but nobody ever contacted me on my contact number 7988293814 provided to authenticate whether I am the wife of Mohd. Shariq or not or whether I am fighting a court case or not. This type of one sided decision despite of the fact that I have provided the details of the court case number is extremely disappointing. And the denial without proper inquiry was the waste of time which made my right to extract legal information tedious. Mohd.
