Highlights of NRL's performance during Q3 of FY 2020-21

Capacity Utilisation

Refinery Crude throughput during the third quarter of the fiscal was 722 TMT reflecting a capacity utilization of 96%. Cumulative Crude throughput during the year upto Dec'20 was 1,990 TMT (88% capacity utilization).

Production Efficiency

Distillate Yield during Oct-Dec'20 and Apr-Dec'20 were 87.07% and 85.88% respectively. Distillate Yield during corresponding period of previous year was 89.10%.

Specific Energy Consumption (SEC) during Oct-Dec'20 and Apr-Dec'20 were 63.19 MBN and 64.6 MBN respectively. MoU target of SEC for the period 2020-21 is 64.65 MBN. SEC during corresponding period of previous year was 63.9.

Similarly, Energy Intensity Index (EII) recorded during Oct-Dec'20 and Apr-Dec'20 were 85.33 and 89.1 respectively vis-à-vis internal target of 87.0. EII during corresponding period of previous year was 86.0.

Capital expenditure

Capital expenditure during Apr-Dec'20 was ₹624 Crore against annual MoU target of ₹620 Crore.

Financial Performance

- Sales turnover during the third quarter of the FY 2020-21 was ₹5,336 Crore while for the period April-Dec'20 was ₹13,009 Crore which is higher by around 17.39% as against ₹11,081.77 Crore of the corresponding period of the previous year.
- Gross Refining Margin during Oct-Dec'20 and Apr-Dec'20 were \$0.82 per bbl and \$1.44 per bbl respectively compared to \$9.89 per bbl in the corresponding period of previous year.
- PBT during Oct-Dec'20 and Apr-Dec'20 were Rs. 1,127 Crores and ₹2,810 Crore.
- PAT during Oct-Dec'20 and Apr-Dec'20 were recorded at ₹841 Crore and ₹2,085 Crore respectively.

MoU with CSIR-NEIST for technical collaboration

 $N^{\rm RL}$ joined hands with CSIR-NEIST for enhancing engineering and technological competence on its R&D

effort. A Memorandum of Understanding (MoU) between NRL and CSIR-NEIST was signed on 21st October 2020 to develop a framework for collaboration between NRL and CSIR-NEIST. The agreement was signed by NRL General Manager (Speciality Chemical), Mr. Ghanashyam Hazarika and Director, CSIR-NEIST, Dr. G. Narahari Shastri in presence of NRL Sr. CGM (Corporate Affairs), Mr. Nikunja Borthakur, SCGM (CA) and other senior officials from NRL and CSIR- NEIST.



Agreement with GAIL for Pipeline Right to use (RoU) Sharing

A historic Pipeline Right to Use (RoU) sharing Agreement was inked between NRL and GAIL (India) Limited on 14th October 2020 at New Delhi. The agreement, a win-win for both the sides was signed by GM (Project) NRL - Mr. P.J. Sarma and GM (Projects), GAIL - Mr. K.K. Sachdeva in presence of MD NRL - Mr. S.K. Barua and CMD GAIL - Mr. Manoj Jain in presence of Directors of GAIL and senior Officials of both the organizations.

Under the agreement, both the companies shall share a common Right to Use (RoU) for laying their respective pipelines for a stretch of 550 Km from Purnia in Bihar to Guwahati in Assam.

GAIL is laying its Barauni - Guwahati pipeline (BGPL), which is a part of Jagdishpur - Haldia & Bokaro - Dhamra Natural Gas (NG) Pipeline Project, popularly known as 'Pradhan Mantri Urja Ganga' extended up to Guwahati to supply Natural Gas to pipelines under North East Gas Grid (NEGG). NRL is also laying its 1,630 Km long Paradip Numaligarh Crude Pipeline (PNCPL) originating from Paradip Port, traversing through the States of Odisha, West Bengal, Jharkhand, Bihar and Assam that terminates at its refinery at Numaligarh (Assam). The pipeline project is part of the mega Integrated Refinery Expansion project from 3MMTPA to 9 MMTPA currently under implementation at a project cost of more than Rs. 22 thousand Crore.

The sharing of the pipeline RoU shall help in optimization of land acquisition for pipeline laying. Both the companies shall also be benefited in terms of resource sharing during execution and operation of the respective pipelines.

Speaking on the occasion Sr. CGM Projects – Mr. A.P. Chakravarty said, 'It is indeed a very happy occasion. A culmination of a long drawn endearvour with the active support and action of all departments – Finance, Commercial, Legal and active guidance, support and direct involvement of the MD, DT and DF.'

MoU with Oil India Limited (OIL) for augmentation of pipeline Capacity

N^{RL} and Oil India Limited (OIL) entered into an MoU on 18th December 2020 to augment OIL's existing pumping capacity through Numaligarh Siliguri Pipeline (NSPL) and increase product evacuation from 1.72 MMTPA to 5.50 MMTPA. The capacity enhancement of NSPL that carries Motor spirit (Petrol), HSD (Diesel) and SKO (Kerosene) is expected to be commissioned by latter part of 2024 to synchronize with the commissioning of the NRL' mega Refinery expansion project of from existing 3.0 MMTPA to 9.0 MMTPA.

Mr. M. K. Pegu, Head (Project Pipeline) NRL and Mr. Sandip Goswami CGM(OPS) Pipeline from Oil India Limited signed the MoU in presence of Honorable Secretary, Department of Public Enterprise, Govt. of India- Shri Sailesh; MD NRL -Mr. S K Barua; CMD OIL -Mr. SC Mishra; Director (Techical) NRL - Mr. B.J. Phukan; Director (Finance) NRL- Mr. Indranil Mittra; Director (Finance) OIL -Mr. Harish Madhav and senior officials of both the Companies at NRL Corporate Office, Guwahati.

This arrangement will help NRL in product evacuation post Refinery expansion and accordingly OIL will replace NRL as project proponent for monitoring of the product pipeline project under National Infrastructure Projects (NIP).

Hon'ble CM performs Bhumi Puja in Dabidubi Land for setting up LPG facilities

I twas a Red Letter day in implementation of NRL's mega Refinery expansion Project as Hon'ble Chief Minister of Assam Shri Sarbananda Sonowal performed Bhumi Puja in a plot of land measuring 362 bighas to mark the inauguration of constructing LPG storage and bottling facilities at Dabidubi in Golaghat district on 21st October 2020.

With bottling capacity of 12,500 LPG cylinders per day and storage capacity of 24,000 MT, the facility is expected to go



a long way in catering to LPG demands of the region, while also decongesting refinery post expansion.

Assam Industries and Commerce Minister Shri Chandra Mohan Patowary, Agriculture Minister Shri Atul Bora, Khumtai MLA Shri Mrinal Saikia, Chairman ATCL Mr. Amiya Kumar Bora along with MD NRL Mr. S K Barua, Director (T) NRL Mr. B J Phukan, Director (F) NRL Mr. Indranil Mittra and senior functionaries along with a host of dignitaries were present on the occasion.

The plant, targeted to be completed in three years, is likely to give direct and indirect employment to several hundred youths of the state.

Hon'ble Chief Minister, while taking a look at the project, lauded NRL for taking initiatives in setting up the project. He also asked them to complete the project within the stipulated time frame so that people in general can reap the benefits of the expansion plan of the NRL which was announced by Prime Minister Narendra Modi-led central government in 2019.

Secretary DPE, Gol visits NRL Corporate Office, reviews Capital Expenditure (CAPEX) Projects

Shri Sailesh, *IAS*-Secretary to the Government of India, Department of Public Enterprises, Ministry of Heavy Industries & Public Enterprises visited NRL Corporate Office at Guwahati on 18th December, 2020 for review of Capital Expenditure(CAPEX) plan of OIL & NRL for the financial year 2020-21. He was extended a warm welcome by MD NRL - Mr. S.K. Barua & CMD OIL - Mr. Sushil Chandra Mishra. The meeting was also attended by Dr. M Ariz Ahammed, IAS -Principal Secretary, Govt. of Assam, Public Enterprises; Director (Technical) NRL- Mr. B.J. Phukan; Director (Finance) NRL- Mr. Indranil Mittra; Director (Finance) OIL -Mr. Harish Madhav and senior officials of both the Companies. Secretary DPE took stock of the CAPEX plans of both the companies in the current fiscal



and beyond and stressed upon the need to speed up the same as envisioned by the Govt. of India in order to boost the economy and sustain the momentum of its revival in the aftermath of COVID-19.

NRL will spend an amount of Rs. 949 Crore in the current financial year for its capital projects. The company has embarked on major projects viz. Refinery Expansion Project from current 3 MMTPA to 9 MMTPA which includes laying of 2200 KM of Crude Oil Pipeline from Paradip port, Odisha to Numaligarh in Assam and Product Pipeline from Numaligarh to Siliguri in West Bengal and associated facilities like Crude Oil Import Terminal at Paradip port. NRL is also laying the 130 KM transnational Indo Bangla Friendship Pipeline (IBFPL) from its Marketing Terminal

> at Siliguri to Parbatipur in Bangladesh. Other than the above, NRL holds equity stake in two important ongoing JV projects including M/s Assam Bio Refinery Pvt. Ltd. (ABRPL) which is implementing the first bamboo-mass Bio Refinery in the country and M/s Indradhanush Gas Grid Limited (IGGL) which is implementing North East Gas Grid connecting all the eight capitals of NE states with National Gas Grid. The pipeline will also cater to the industrial customers in the NE states including NRL.

SAP HANA migration starts in NRL

 $S^{/4}$ HANA migration project commenced in NRL on $15^{\rm th}$ December'2020 through a virtual kick off meeting on Microsoft teams. HANA is an in-memory database developed by SAP, suitable for analytical operations.

MD Mr. S . K Barua, DT Mr B J Phukan and DF Mr. I Mittra were present at the meeting and share their views on how the new system would improve overall performance of SAP applications in the organisation.

From SAP side, Ms. Sunita Mohanty, Head of Services SAP India elucidated about the way forward and benefits of migration to HANA.

So far, SAP has been used as transaction processing system in day to day operation, having integration with peripheral systems like Terminal Automation System(TAS), IP21 process historian etc. Over the period, substantial data growth has occurred in the transactional ERP system as well as in the peripheral systems. The need for a system, capable of drawing information out of the data for further optimization of resources and improvement of performance is felt.

HANA is an acronym for High Performance Analytical Appliance. As the name suggests, it will improve performance due to its ability to process data faster with embedded analytical capability. Following benefits shall be derived from S4 HANA migration project;

- Mobility of data access through device agnostic Fiori application. SAP data will be accessible on mobile phones and tablets in addition to laptops and desktop computers.
- Real time monitoring of the KPIs.
- Dynamic reporting with analytical and graphical view of data.

m A}$ efficiency, productivity, and quality across industrial operations at plant, NRL has implemented Operation Management Solution j5, by Hexagon's PPM, a global leader in software and autonomous solutions to ensure safe, efficient, compliant operations of their industrial sites. On 23rd of December 2020, MD Mr. S.K. Barua inaugurated the solution in presence of Director (Technical) Mr. B.J. Phukan, Director (Finance) Mr. Indranil Mittra and other senior officials of NRL and Hexagon. The implementation will enable electronic and mobile Operations Management System (OMS) that is easy and intuitive, enabling improvement in work efficiency, significant reduction in business hours by enhancing operator skills and supporting technology adoption. It would also have a more robust stable.advanced business operations and technology transfer to young staff by having digitized shift handover

with digital shift operations log, work & standing instructions. The OMS also have working interfaces with Historian and ERP modules.

NRL will follow a phased approach for OMS deployment and has kicked off the implementation with five units – Power and Utility, DHDT (Diesel Hydrotreater), Hydrocarcker, SDU and Marketing Terminal. Refinery wide implementation of the solutions is planned soon. Hexagon's j5 OMS will empower NRL team with advanced business operations and technology transfer capabilities.j5 Shift Handover will improve shift-to-shift communication and reduces the risk of hazardous incidents, equalingindustry wide shift handover recommendations by experts. j5 Mobility will allow personnel to collect measurements or observations in the field with industrystandard mobile devices. j5 Mobility will also be used to record manual data in field that is missing from industrial software like Data Historians.

On the occasion of go live function at NRL Central control room our MD Mr. S.K. Barua congratulated team NRL and Hexagon and said 'NRL is adopting multiple digital initiatives to improve productivity and bring agility business decisions and solutions like j5 operations management will accelerate and support our digital transformation by enabling us to optimize our business operations.'

Shri Dharmendra Pradhan invites investors, developers and businesses to be a part of India's renewable energy journey;

India is in the midst of a major transformative shift in its energy sector, to end energy poverty in India, says the Minister

The Minister of Petroleum & Natural Gas and Steel Shri Dharmendra Pradhan has invited investors, developers and businesses to be a part of India's renewable energy journey, assuring them that it will be a highly rewarding and mutually beneficial venture. In the Valedictory Address at the 3rd RE-INVEST 2020 on 28th NOV 2020, he said that India is progressively becoming a favoured destination for investment in renewables. During the last 6 years, over US\$ 64 billion investment has been made in renewable energy in India.

Shri Pradhan said that India has a very liberal FDI policy in energy sector, including renewables. "Foreign investors can either invest on their own or enter into joint ventures with an Indian partner for financial and/or technical collaboration for setting up of renewable energy-based power generation projects.", he said. The Minister assured that "Ease of doing business" is our utmost priority. "Our continuous focus is on maintaining sanctity of contracts and safeguarding investments. We have established dedicated Project Development Cells (PDC) and Foreign Direct Investment (FDI) cells in all Ministries for handholding and facilitating domestic and foreign investors. Adequate measures and safeguards have also been undertaken to address the concerns of businesses and investors arising out of the Covid pandemic."

Shri Pradhan said that India is in the midst of a major transformative shift in its energy sector, to end energy poverty in India. "While doing so, our twin objectives are to enhance availability and affordability of clean fossil fuels and green fuels, and to reduce the carbon footprint through a healthy mix of all commercially-viable energy sources. We are consistently taking energy policy initiatives. Revamping policies, and taking needful measures. We are developing next generation infrastructure based on five guiding key enablers of energy availability and accessibility to all, energy affordability to the poorest of the poor, efficiency in energy use, energy sustainability to combating climate change as a responsible global citizen and security for mitigating the global uncertainties."The Minister mentioned that our energy agenda is inclusive, market-based and climate sensitive.

Shri Pradhan highlighted several initiatives that are spearheaded by the Indian oil & gas industry to broaden the Renewable Energy canvas, and also are also offering enormous investment opportunities. "We have embarked on a major biofuel programme in the country, which has huge investment opportunities. Biofuel is not just science but also a Mantra that will provide a new energy to not only India but also the entire world. It has the power to create a balance between our environment and economic development. We have launched the National Biofuel Policy (NBP) in 2018 to promote biofuels in mass scale with a target of 20% ethanol blending in petrol and 5% of biodiesel by 2030. We are setting up twelve 2G Ethanol Bio-Refineries in 11 States with an overall capacity of 1100 Kilo Litre per Day (KLPD)." The Minister mentioned another major transformative energy initiative in the country of developing a gas-based economy leading to 'One Nation One Gas Grid'. "We have already laid over 16,800 km long gas pipeline network, and additionally 14,700 km gas pipelines are under different stages of construction. An estimated investment of 60 billion US dollars is lined up in developing gas infrastructure, which includes pipelines, city gas distribution and LNG regasification terminals. The vast gas-based infrastructure will offer enormous opportunities for integrating different sources of energy in the country. This is yet another potential area of growth with vast investment opportunities",he said.

Shri Pradhan invited the participants to look at the investment opportunities in Compressed Bio-Gas (CBG) initiative. "We have a well-developed roadmap for SATAT (Sustainable Alternative Towards Affordable Transportation), an important initiative of our government, which targets to setup 5000 compressed biogas plants with a target of 15 MMT per year with an investment potential for US \$ 20 billion. Indian oil marketing companies are offering to private entrepreneurs assured price and offtake guarantee. The SATAT initiative is in line with the goals of AatmaNirbhar Bharat, Swachh Bharat Mission and boosting MSME sector. Reserve Bank of India has included CBG projects under Priority Sector that will help in getting the loan for CBG plant. I am glad to inform that a total of 1500 CBG plants are at various stages of execution.

Shri Pradhan mentioned that speaking at the fourth India Energy Forum by CERA week last month, Hon'ble Prime Minister highlighted seven key drivers of India's energy strategy going forward. He said that apart from achieving the renewable energy target of 450 gigawatts (GW) by 2030, India will focus on developing in an integrated manner a gas-based economy, cleaner use of fossil fuels, greater reliance on domestic fuels to drive biofuels, increasing the contribution of electricity, moving into emerging fuels like Hydrogen, and promoting digital innovation across all energy systems.

The Minister said that oil and gas companies in India including oil PSUs are investing in developing renewable energy projects by focusing more on green energy investments such as renewables, biofuels and hydrogen going forward.

The Minister said that as COVID-19 challenges the fundamental assumptions of our lives, the urgency of a green revolution in the energy sector gains greater importance. "While the immediate economic impact may slow us down, we are presented with an opportunity to pause, rethink, and design a new and faster transition to a low carbon future more aggressively.", he said.

The Story of NRL – XVII

The articles cover the history of NRL from its birth in the words of a pioneer, who has seen it all.

n the previous article, I had tried to cover some of the major activities continuing/planned during the period up to 2007. I would cover the same activities to their completion in this present Article.

The Duliajan-Numaligarh Gas Pipeline to transport 1 MMSCMD Natural Gas at a pressure of 40Kg/Sq inch was taken up for construction by the newly formed JV Company, DNPL Ltd. Neither AGCL nor NRL had any experience to execute a critical high pressure gas pipeline project. Obtaining the right of way was difficult and it took some time to fully obtain the same. The pipeline had to be laid across numbers of small and big rivers. A new technology, Horizontal Directional Drilling (HDD) was adopted for the first time in Assam for river crossings. This technology enables drilling through the river bed without causing ground disturbance, water contamination and minimal disturbance to the environment. Application of this technology helped save time,cost and effort in construction of the pipeline. As the job was divided among many local contractors constant co-ordination and follow up was necessary. Execution of the despatch terminal comprising of gas receiving/

monthly meetings was introduced from October 2007 with all involved. Besides above, follow up mechanism with Vendors also strengthened and regular reviews continued at site. The expediting

actions taken helped to sort out many critical issues and the project was put on track. Continuous monitoring of critical activities helped make steady progress. The Product pipe line project, as discussed earlier, was being executed by OIL. For de-waxing the old Crude oil pipe line OIL had to induct a Chinese firm. The project experienced some delays mainly due to River Crossings at some places. The receiving infrastructure atOIL's facilities were progressing well. The State-Of-The-Art Marketing Terminal was completed at a cost of Rs. 180 Crores and commissioned in synchronisation with the pipe line Project in April 2009 on receipt of first batch of Kerosene directly from the OIL's Despatch Terminal at Numaligarh. Both Rail and Road loading facilities were commissioned soon thereafter.

On establishing the viability of setting up the Wax Unit by carrying out

despatch facilities and installation of high pressure compressors were taken up at Madhuban, Duliajan. The high pressure gas receiving station at the Refinery end was also taken up by DNPL. Self and Sri S.K.Barua were deeply involved with the process of execution. A few officers of NRL were placed on deputation to DNPL. The activities from high pressure gas receiving station within the Refinery to the Power plant and Hydrogen plant were taken up by NRL. The 191 KM Pipeline project was commissioned November 2009 at a cost of Rs 346 Crores. With this NRL was linked to an assured and steady source of supply of Natural Gas. Utilising Natural Gas in



the pre-feasibility study there was no looking back. EIL was appointed to carry out the Detailed Project Report. Meanwhile, the technology adoption in association with IIP, Dehradun was in the final stage. The DPR established the feasibility and economic viability of setting up a 50,000 TPA wax plant comprising of 45,000 TPA Paraffin Wax considering MVGO as feed and 5000 TPA Microcrystalline Wax considering HVGO as feed. The configuration include a Solvent Dewaxing Unit, Vacuum filtration Unit, Hydrofinishing Unit, Slabbing and packaging Unit, Tankages and a Blast proof Control Room. The Units and facilities were decided to be set up

the Power Plant as fuel, feed and fuel in the Hydrogen plant and as fuel in other process plants helped in improved operations, reduction in Fuel and Loss, and saving of valuable Naphtha. The additional generation of Naphtha helped increase MS production which led to improvement in profitability of the Company.

Execution of the Siliguri Marketing Terminal Project (SMTP) turned out to be a big challenge. Progress of construction was low due to contractual and local issues. Huge amount of earth filling works were involved and it was difficult to source the required earth from nearby areas. Progress of civil works and construction of tankages were much below the desired level. Due to the difficulties faced, number of contractual issues also appeared. A project team headed by Sri J. C. Kalita was managing the project. At this critical stage, It was decided to put much more impetus from the Management for timely completion of this project located in West Bengal. Accordingly, it was decided to hold regular meetings with the contractors, consultants, local groups, and local administration at the level of Director (Technical). Practice of in adjoining plots near the existing SRB as there was no other suitable single plot available to accommodate all the Units and facilities. This decision helped keeping the area opposite HCU free for any possible future expansion. The Project was approved by the Board at a cost of Rs.616 Crores. Subsequently, EIL was appointed as the PMC and project implementation activities were taken up during 2009. I shall discuss the implementation of the Project in the next Article.

The concept, feasibility and preliminary activities related to the Diesel Quality Up gradation Project was discussed in the previous article. The project was approved by the Board at a cost of only Rs. 434Crores, The implementation required a total Refinery shut down for 60 days. Approval for 60 Days turnaround was needed to be taken from the Ministry as the Crude suppliers OIL and ONGC had to plan their Production schedule in sync with our plans.

Engineering and procurement activities were taken up in association with the PMC much in advance. Procurement activities for the shut down

related jobs were also taken up. Engineering drawings, piping Isometric drawings etc were prepared in advance to enable pre-fabrication works at site. Contracts for all jobs were lined up much in advance. A large volume of dismantling works for both low pressure and high pressure piping sections were required. Some specific and critical decisions were to be taken. To mention a few, it was as per design, an additional Off gas compressor and an additional Make-Up Gas compressor were required to be installed. On detail examination, it was observed that there was no space to install the same as OISD distance norms could not be met, which became a big constraint. A bold decision was taken to operate the existing Make-Up Gas Compressors at their full capacity in tandem deviating from the original operating practice . Similarly, the operating philosophy of the existing Off gas compressor was also changed in the same way. Thus installation of an additional Make-Up Gas Compressor and an Off-Gas Compressors was avoided. The single Recycle Gas Compressor was decided to be retained as it had required additional capacity. The Fractionator of HCU, HP Heat Exchangers, Feed Pumps etc. were also to be replaced. Additional Instrumentation works including modification in the control panels, PLCs etc. were called for. Similarly, modification works for electrical systems also needed as lots of Pumps and equipments were to be replaced with high volume ones.

In the Hydrogen Generation Unit one of the major critical jobs was replacement of cold collector. Jobs related to change of the Naphtha Feed pumps, modification of Steam generation System, conversion of 6 Bed PSA Unit to a 10 Bed one etc were also critical. Besides change of Catalysts in HCU Reactors and all Catalyst systems including reformer catalysts in HGU were to be taken up. Replacement of 35 nos.of Reformer tubes also were due.

Shut down related jobs in CDU/VDU, DCU, Utilities and offsite were to be taken up. The Sulphur Recovery Block also needed revamping to increase its capacity to handle additional Gas and Sour Water and increased production of elemental Sulphur. On examination of the Flare System it was observed that the existing flare system had enough capacity to handle additional flare gas. However, new Hook -ups in the flare header were necessary. The Capacity of the Nitrogen Plant was to be enhanced by installing a new train. The volume of work was huge and there were many critical and high pressure jobs.

It was a challenge to complete the project within the stipulated period of 60 days. As mentioned earlier, ordering of material and lining up of contracts were done much in advance which helped carry out major piping works in the operating plants adopting strict fire and safety measures. Foundation works for installation of new pumps and vessels including foundation works for pumps and equipments were to be done in the operating plants and some of the equipments were also to be installed. Considerable amount of underground works also were to be carried out in the operating Units. Primarily, hook up jobs, installation of Equipments, Heat Exchangers, Feed pumps etc were done during the pre- shut down period. The 60 days shutdown was taken as planned on 15th April 2010, The jobs started without losing a single hour.

Progress review meetings were held at the field office with the concerned departments, contractors and consultant in the Morning and in the Evening. To save idle time, Breakfast/evening tea, lunch/ dinner for all workmen were provided at the locations. The HR department saw that all human related issues were promptly addressed to and there was no IR issues. The jobs were progressing smoothly and as planned. However, a major setback occurred when incessant rain of very high intensity started in the middle of May. In fact, the rainfall recorded was highest in many decades. That started affecting the progress adversely

as it became difficult to work. Special rain protective sheds/ canopies etc. were erected in strategic areas to help continue work during heavy rain. Meanwhile, the execution was slipping on schedule. As OIL and ONGC planned their Crude production in sync with DQUP Project, crude oil inventories were building up at their end which threatened reduction in Crude production, an unacceptable situation to both OIL and ONGC. The Ministry also became alert with the situation. We were summoned to Delhi every week by the Ministry for reviews and weekly meetings were held at Director's level of OIL and ONGC. Utmost efforts were put by everyone so that project works continued even under heavy odds. Finally, with a delay of about 21 days the DQUP project works and shut down jobs were completed in end July 2010. The DQUP was successfully commissioned along with commissioning of the Refinery. It may be mentioned that The Hydrocracker started functioning smoothly with increased capacity and helped overcome many of the earlier constraints faced by the Unit. The DQUP project tested the engineering ability, project management skills, co-ordination ability, HR capability and commitment of the Management and all employees. In fact, it was a project which many organisations would not have ventured as it involved very high risk, both at individual and corporate level. It was a great success story of NRL as NRL joined the BS IV HSD production league in August 2010 at a cost of only Rs. 434 Crores and at the shortest possible time.

Developments regarding the Corporate Office at Guwahati was discussed in the last article. In early 2007, it was decided that NRL shall have its corporate office in the new plot of land. Initially, it was decided to construct a low cost pre-fabricated building (a new technology at that point of time). Accordingly, a two storey 10,000 sq ft pre-fabricated building was conceived at a cost of around Rs. 10 Crores with an execution period of only 6 Months. The foundation stone was laid in January 2010 and the construction was completed in November 2010 by the then MD Shri B.K.Das. Immediately thereafter, the Corporate office was shifted to this newly constructed pre-fabricated building. Subsequently, it was decided to construct a Corporate Building at the same plot of land. It was proposed that the design of which shall be done by one of the best Architects in the Country. The idea of a twotower building was conceived and Architect Hafiz Contractor was engaged for design and execution of the building. However, due to larger land requirement this idea was to be dropped and the present single tower structure was considered. The Board approval was obtained in 2011 for construction of the Building in two phases. The first phase was estimated to cost Rs. 57 Crores. The foundation stone was laid in April 2011 and the construction commenced soon thereafter.

As discussed earlier, NRL continued to take challenging projects/ activities since its inception and completed and commissioned the same successfully. NRL by that time became a Refinery capable of producing both Euro IV grade MS and HSD with State –Of-The- Art Technologies, it started Marketing Operations by setting up its own retail net work including supply of HSD to Bangladesh. During the period NRL improved its performances in the areas of Refinery Operations, Fire and Safety management, Marketing and Corporate Affairs. For which, NRL continued to earn awards and accolades from various Govt. & Statutory Bodies, Societies and Non Governmental Organisations.

Since the first year of operation, NRL continued to be a profitable and dividend paying Company. The net profit earned up to 2010-11 from the first year of operation was Rs.3,075 Crores of which Rs.1,085 Crores was paid as Dividend to the Promoters. With sustained positive net profit NRL's contribution towards CSR activities also increased year after year.

Stress and Anxiety: A boon or curse???

"It's not stress that kills us, it is our reaction to it" - Hans Selye

Stress and anxiety has been a part and parcel of the modern society. Anxiety may be defined as a feeling consisted of fear, worry and unease. Anxiety could not even be subtracted in the absence of stress. It causes havoc in day to day life via creation of various circumstances such as loss of concentration, fearing of some unknown entities, confusion, sense of helplessness etc. According to many authors, anxiety is a common emotion. However, over-expression and irrational emotions lead to mental disorder. Similarly, stress is also a normal event of our life. So far as medical science is concerned, stress is a physical, mental or emotional factor that can cause bodily or mental tensions. Factors responsible for creation of stress may be of two types:

- i) External factor: Environment, Psychological and Social situations
- ii) Internal factor: Chronic illness, injury, paralysis etc.

There is considerable confusion and disagreement in the psychological and psychiatric literature regarding the meaning of stress and anxiety. The above paragraph offers some of the important distinctions between the two constructs, and outlines some causal relationships between them. Over the past few years, research interest in this field has stood up dramatically. This interest has produced a variety of theoretical and methodological approaches and the proper methodology for assessing these constructs. Both field experimentations and laboratory research have investigated various hypothesis, out of which majority of the works were focused on social evaluation. Studies revealed that stress and anxiety have been crucial contributors to many chronic diseases and to decreased quality of life, even with pharmacologic treatment. Worldwide efforts are underway to find and develop some promising non-pharmacologic therapies against the aforesaid traits.

Stress and anxiety may not always be harmful. If it doesn't last long it may pave a positive way for being motivated towards yoga and meditation. Nowadays, yoga and meditation is creating a wonderful impact on the society in reducing stress and anxiety in particular bringing incredible stability in mental health. People having stress and anxiety over longer period of time may experience negative health outcomes. They are more likely to develop



heart disease, high blood pressure, depression and panic disorder. Some of most common consequences may be: headache, restlessness, sleeplessness, chest pain, irritation, sudden mood swings, tendency to commit suicide etc.

Some of the most common non pharmacologic tools apart from yoga and meditation are stated below:

Aromatherapy: Using essential oils or lighting of scented *agarbattis* may help in reducing mental stress and anxiety.

Laughing: Laughing has proved to be a boon towards improving immunity and mood as well. Watching funny videos, TV shows or hanging out with good friends may work suitably in this context.

Music: Listening to music may also have a relaxing effect on the mind and body as a whole.

Diet: Consumption of alcohol, smoking, addiction towards drugs and other sedatives plays a negative role on our day to day life which in turn may act like *icing on a cake* in this respect. Hence, maintaining a proper, healthy and balanced diet would always be fruitful.

Hobbies: Developing interest in various hobbies such as gardening, reading novels, playing an outdoor game etc. may also help in reducing stress and anxiety. Spending time with family and friends is also noteworthy.

Exercise: Daily exercises for at least an hour is one of the most effective tools in combating the aforesaid disorder. It has immense role in lowering stress hormones of the body and empowers certain other factors *viz.*, endorphins

that may improve a person's mood and act as natural pain killers which would also endorse some good sleep.

Various studies and social media platforms have reported on the development of stress and anxiety on many people across the globe during the recent pandemic situations of Covid-19. In this context, governments of different countries have taken necessary steps to mitigate the overall situations. In India, the state of Kerala has launched a project to counsel school students to overcome stress and anxiety. This is because the young students were the worst affected. It has been observed that the above mentioned remedial tools have been proved to be very much effective in conquering the threat of stress and anxiety that has been evidenced by many scientific publications. Henceforth, it is important to recognize when the stress in one's life is causing negative consequences. If anyone feels that stress and anxiety are becoming unmanageable, it is always advisable to seek help of the concerned professionals and ask others to help find the support he/she needs rather allowing stress and anxiety to get overloaded and lead to some unwanted consequences.
